Pursuant to the Freedom of Information Act, I hereby request the following records:

Dear FOIA Officers,

Under the Freedom of Information Act (5 U.S.C. 552), I am requesting access to and copies of records that detail the locations and descriptions of all decommissioned nuclear bomb shelters, as well as all facilities intended for the continuity of government operations, within the District of Columbia.

Please include any records related to the planning, construction, operation, and decommissioning of these facilities. I am interested in any maps, building plans, historical documents, policies, and communications regarding the operation and status of these sites, particularly those that are no longer in active use.

I believe these records are important for public understanding of historical government preparedness measures and are likely to contribute significantly to public knowledge of government operations and activities.

If certain parts of these records are deemed exempt from disclosure, I request that you provide all segregable portions that are disclosable.

I am willing to pay fees for this request up to a maximum of \$25. If you estimate that the fees will exceed this limit, please inform me first.

Please confirm receipt of this request. I look forward to your response within the statutory 20 business day period, as outlined under FOIA.

Thank you for considering my request.

The requested documents will be made available to the general public, and this request is not being made for commercial purposes.

In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not.

Thank you in advance for your anticipated cooperation in this matter. I look forward to receiving your response to this request within 20 business days, as the statute requires.
