The defendant, who was unlawfully carrying a concealed 9mm Glock handgun in a non-retention holster inside his right waistband, attempted to retrieve the firearm. During the physical altercation the victim intervened between the two and was able to separate them. Once the defendant and Del Toro Sr. separated, the defendant produced the firearm, pointed it in the direction of the victim and discharged a single round. The bullet

During a post Miranda interview with the defendant, he admitted to carrying a concealed firearm without a concealed carry permit. The defendant admitted that he got aggravated during the physical altercation and pulled out the firearm, but did not mean to discharge it. The defendant also stated without his glasses on he is unable to see.

The defendant was unlawfully carrying a concealed firearm. The defendant produced a firearm during a physical altercation when he was aggravated and unable to see. The defendant pointed the firearm in the direction of the victim and his father. The defendant discharged the firearm one time, which resulted in the death of the victim. The defendant's actions showed a gross and flagrant course of conduct, which was a reckless disregard for human life and the safety of persons exposed to the dangers.
