AFFIDAVIT

The undersigned upon oath deposes and states as follows, to-wit:

That your affiant, JOSHUA BRANCH, is a CLEET-certified and commissioned peace officer in and for the State of Oklahoma and is currently employed as a Special Agent for the Oklahoma State Bureau of Investigation (OSBI). Your affiant has been a commissioned peace officer since December 14, 2009 and I currently hold an Advanced Law Enforcement Certificate from the Oklahoma Council on Law Enforcement Education and Training. Your affiant worked as a Police Officer for the City of Duncan, Oklahoma for over 12 years. While employed with Duncan Police Department, your affiant spent over 3 years assigned as a Detective in the Criminal Investigation Division. Your affiant has worked as a Special Agent with the Oklahoma State Bureau of Investigation since October 2022. Your affiant obtained a Bachelor of Science Degree from Oklahoma State University. Your affiant graduated the 71st CLEET Criminal Investigation Academy and has completed over 1300 hours of continuing education. Your affiant graduated the 19th Oklahoma State Bureau of Investigation Agents Academy. Your affiant is also commissioned under a Special Deputation by the United States Marshal's Office as a member of the Safe Trails Task Force.

On Saturday May 11, 2024, Chickasha Police Department Chief Goebel Music requested Oklahoma State Bureau of Investigation investigative assistance with a triple homicide at 1008 South 6th Street in Chickasha, Oklahoma. Music advised that Chickasha Police Department received a 911 call at approximately 1123

hours on hours on May 11, 2024, stating that there were shell casings on the front porch of 1008 South 6th Street and possible deceased people inside the house.

Chickasha Police Department Lieutenant Jeremy Alexander, Master Sergeant Chad King, Police Officer Andrew Kammerlocher, and Police Recruit Eric Robledo responded to 1008 South 6th Street in Chickasha, Oklahoma. Grady County Sheriff's Office Lieutenant James Weidenmaier forced entry into the front door of the residence at 1008 South 6th Street after knocking and announcing with no response from inside the residence. As officer's entered into the residence they observed a black AR-15 rifle laying in the front entry way inside the residence. Agents later identified the serial number on this AR15 rifle as SCB745312, this serial number matched the serial number on the AR15 rifle purchased by Jacob Mayhugh on April 25, 2024. Several spent 5.56 shell casings were located on the ground inside the residence. Immediately to the right of the doorway was a female, later identified as Patty Mayhugh, lying on the ground with apparent gunshot wounds who was obviously deceased. There was a male, later identified as James Mayhugh, lying on the floor in the living room of the residence with apparent gunshot wounds who was obviously deceased. Another female, later identified as Shayla Mayhugh, was located on the floor between James Mayhugh and the couch in the living room of the residence with apparent gunshot wounds who was obviously deceased. Chickasha Police Department cleared the remainder of the residence and secured the crime scene.

Chickasha Police Department Master Sergeant Chad King knew that the Mayhugh family that lived at 1008 South 6th Street also owned the home at 1002 South 6th Street. Shayla lived with her brother Jacob Mayhugh at 1002 South 6th Street in Chickasha, Oklahoma. Jacob could not be located and a gray colored GMC Yukon that Jacob was known to drive could not be located. Chickasha Police Department Lieutenant Jeremy Alexander obtained search warrants for both 1008 South 6th Street and 1002 South 6th Street in Chickasha, Oklahoma.

Oklahoma State Bureau of Investigation Captain Brenna Alvarez, Lieutenant Michael Francis, Special Agent Josh Branch, and Special Agent Monty Reed arrived on scene. Oklahoma State Bureau of Investigation Crime Scene Agent Brad Delozier also arrived on scene.

Grady County Sheriff's Office Tactical Team served the search warrant at 1002 South 6th Street in Chickasha, Oklahoma. The residence was clear and no one was located inside.

Oklahoma State Bureau of Investigation Crime Scene Agent Brad Delozier processed the scene at 1008 South 6th Street. Office of the Chief Medical Examiner Investigator BROCK SMITH arrived on scene and processed the three deceased individuals. The three deceased individuals were transported to the Office of the Chief Medical Examiner in Oklahoma City, Oklahoma.

On May 10, 2024, Jacob Mayhugh told his girlfriend [REDACTED] that he was going to eat pizza at his parents house at 1008 South 6th Street. Jacob Mayhugh left Summer's apartment at 1643 hours. At approximately 1722 hours Patty Mayhugh texted Jacob Mayhugh that dinner was ready. The text message was found during an analysis of Patty Mayhugh's phone.

Oklahoma City Police Department Violent Criminal Apprehension Team checked the Flock cameras in the Oklahoma City area and located the gray 2000 GMC Yukon bearing Oklahoma license plate FIG110 which Jacob Mayhugh was known to drive. The vehicle was observed several times throughout Oklahoma City, Oklahoma from 1844 hours on May 10, 2024 until approximately 1630 hours on May 11, 2024 when the vehicle was located parked near the intersection of Walker and California in Oklahoma City, Oklahoma. The vehicle was parked and locked with no one around the vehicle.

It was determined by Flock cameras that a male parked the vehicle and walked away on foot at approximately 1907 hours on May 10, 2024. The male who walked away from the vehicle was identified as Jacob Mayhugh by [REDACTED].

Oklahoma State Bureau of Investigation Special Agent Joseph Gravelle obtained a search warrant for the Gray 2000 GMC Yukon bearing Oklahoma license plate FIG110. Upon search of the vehicle Special Agent Gravelle located a black cellphone in a pink case, a black wallet containing an Oklahoma Driver's License for Jacob Mayhugh and seven hundred thirty-eight dollars in cash, car keys to the vehicle, and 2 AR15 Magazines loaded with ammunition with writing on them in white paint pen.

On May 13, 2024, Oklahoma State Bureau of Investigation Special Agent Daniel Perkins went to Two Vets Clothing Company, 1427 South 4th Street, Chickasha, Oklahoma. Perkins received a copy of paperwork showing that Jacob Mayhugh purchased a Palmetto PSA15 5.56 caliber rifle with serial number SCB745312 on April 25, 2024, and a Taurus G3C 9mm handgun with serial number AOB014204. The two firearms were later located inside the crime scene at 1008 South 6th Street along with multiple 5.56

shell casings in the area of the residence with the deceased individuals.

The AR15 magazine located inside the firearm found on scene had white paint pen writing on it similar to the markings found on the 2 AR15 magazines recovered from the gray GMC Yukon.

Each and every fact known in this investigation is not included in this affidavit, just what is needed to establish probable cause. Based off the above information, it is requested a warrant be issued for the arrest of Jacob Mayhugh for First Degree Murder, Oklahoma S21-701.

Based upon this information, the undersigned prays that this Honorable court issued a finding of fact that probable cause exists to believe that a crime has been committed and that there is probable cause to believe the defendant(s) above named committed that crime.
