The Criminal Division acknowledges receipt of your Freedom of Information Act request dated April 14, 2023. Your request was received in this Office on April 14, 2023. In that request, you asked for access to records concerning the above-mentioned subject. Your request has been assigned file number CRM-301942554. You should refer to this number in any future correspondence with this Office.

With respect to Part 6 of your request regarding Josh Smith, to the extent that non-public responsive records exist, without consent, proof of death, or an overriding public interest, disclosure of law enforcement records concerning an individual could reasonably be expected to constitute an unwarranted invasion of personal privacy. <u>See 5</u> U.S.C. § 552(b)(7)(C). Because any non-public records responsive to your request would be categorically exempt from disclosure, this Office is not required to conduct a search for the requested records.

With respect to Parts 1-5 and 7 of your request regarding Tennessee State Senator Brian Kelsey, please be advised that I have decided to neither confirm nor deny the existence of such records pursuant to Exemptions 6 and 7(C) of the FOIA. 5 U.S.C. § 552(b)(6), (7)(C). Even to acknowledge the existence of law enforcement records on another individual could reasonably be expected to constitute an unwarranted invasion of personal privacy. This is our standard response to such requests and should not be taken to mean that records do, or do not, exist. Accordingly, I cannot confirm nor deny the existence of records responsive to your request.

As to your request for a fee waiver and preferred fee status, your request is moot as there are no fees associated with this request.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. <u>See</u> 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all requesters and should not be taken as an indication that excluded records do, or do not, exist. 2
