AFFIDAVIT of PROBABLE CAUSE

Your Affiant is a sworn member of the Pennsylvania State Police stationed at PSP-Bells Vernon currently assigned to the patrol unit.

On 05/29/2024 at approximately 0150 hours, I was on routine patrol in a marked patrol unit (B2-10) in full duty uniform. At this time, I was dispatched to 703 Stauffer St., Upper Tyrone Twp., Fayette County to third party reports of a female in distress in which her mother is acting erratic. Upon arrival, contact was made with Faryn Leigh DEWITT and an Interview was conducted.

F.DEWITT stated that she went to Sheetz for food around midnight 05/29/2024 and returned home at approximately 0030 hours. Upon her return, she heard acreaming coming from the upstairs of the residence. F.DEWITT related that her mother, Marylou DEWITT, had chained her mentally handicapped adopted sister, Madison GILLAM, to a bed for an unknown period of time in which she only had access to sandwiches and no food. F.DEWITT located the keys to the chains and handcuffs in a lunch box. She freed her sister and then placed the restraints in the lunch box. Marylou DEWITT then returned to the household and attempted to clean up the room by placing the mattress back on the bed. She also grabbed the lunch box containing the restraints. F.DEWITT related that she confronted Marylou DEWITT and prevented her from tampering with the scene. Marylou DEWITT then left the residence with the lunch box.

F.DEWITT produced a video and photographs documenting her initial observations. The video depicted GILLAM handcuffed to a wooden bed frame and a chain that wrapped around her neck. The chain was wrapped in a pink t-shirt. A bike chain could be scene that restrained GILLAM at the hip area. GILLAM face was swollen. GILLAM related that Marylou DEWITT had been began doing this last week and only left her sandwiches to eat. GILLAM stated that she had been making her "pee and poop' herself. Pictures showed bruising on GILLAM's right leg.

I then conducted an interview with Madison GILLAM on scene.

AFFIDAVIT of PROBABLE CAUSE CONTINUATION

GILLAM related that she had been restrained to the bed since May 24,2024 and had no access to water. She was only given access to sandwiches in ziplock bags and had no water. She further related that M.DEWITT has not let her shower since February or brush her teeth. GILLAM added that M.DEWITT would not let her take her medicine and she was at risk of having seizures without it.

I observed bruising on GILLAM's right leg. A strong odor of urine and body odor was emanating from her person.

I then observed the room in which Gillam was restrained. There was a wooden bed frame in the center of the room with no mattress on it. The mattress and bedding were against the wall away from the bed. A strong odor of urine was present in the room. Wear marks were observed on the wooden headboard where Gillam was handcuffed.

I was informed that GILLAM had been diagnosed with Bipoplar Disorder and ADHD.

M.DEWITT was aware that police were notified and refused to return to the residence. M.DEWITT then began sending suicidal messages to family members.

Pennsylvania State Police Cpl.WEBB made telephone contact with M.DEWITT and began negotiations with her. M.DEWITT refused to return to scene. Cellphone pings were then used to locate M.DEWITT in the area of Monroeville. Monroeville PD canvassed the area with negative results. ANother cellphone ping was initiated and pinged again in the Pittsburgh area. Pittsburgh PD located M.DEWITT, driving a white In color 2022 Mitsubtshi Outlander bearing Pennsylvania Registration: LVD8309. M.DEWITT refused to pull over when police attempted to conduct a traffic stop. PSP-Pittsburgh entered into the pursuit. Cpl.WEBB continued to speak with M.DEWITT and convinced her to surrender to pursuing units. M.DEWITT was taken into custody without further incident.

Video and photographs were entered into evidence under property record #: 802-16149.

Search Warrant for the aforementioned vehicle pending.
