- 1. Appeal must be filed within thirty days of the Judgments in the Superior Court. OCGA 5-6-38(A)
- 2. Include the title and docket number of the case. OCGA 5-6-37
- 3. Include the name of the appellant and name and address of his/her attorney. OCGA 5-6-37
- 4. Include a statement of the Judgment, Ruling or Order allowing the Appeal. OCGA 5-6-37
- 5. State the higher court being appealed. OCGA 5-6-37
- 6. Include a Designation of Record to be omitted and a statement of the appellate jurisdiction. <u>OCGA 5-6-37</u>
- 7. State whether a transcript is to be transmitted with the Record. OCGA 5-6-37
- Include a Certificate of Service showing the <u>full name and address of the</u> <u>opposing counsel or party and a signature of the party or attorney of record</u>, along with the State Bar number of the attorney signing the Notice of Appeal. <u>OCGA 5-6-37</u>
- 9. If the appellant is indigent, include an Affidavit of Indigency. OCGA 15-6-80
