**DEFENDANT JOHN EASTMAN’S MOTION TO ADOPT
CO-DEFENDANTS’ MOTIONS RE IN RE LONEY ISSUE**

Defendant John Charles Eastman (“Eastman”), by and through undersigned counsel, does here file an “Authorized Motion To Adopt Co-Defendants’ Motion Re In Re Loney Issue”.

Specifically, regarding Counts 15 and 27 Eastman adopts Part II of Defendant Donald J. Trump’s Motion To Dismiss, filed January 8, 2024, including the motion itself, together with supplemental briefing, filed April 24, 2024, in support thereof;

Eastman also, regarding Count 15, moves to adopt Defendants David James Shafer (“Shafer”) and Shawn Micah Tresher Still’s (“Still”) Pleas In Bar, filed September 27, 2023 and October 2, 2023, respectively and briefs in support thereof, filed April 25, 2024 and April 24, 2024, respectively regarding Count 15, the conspiracy offense, regarding the electors that parallel the substantive counts against

Shafer and Stills, with the caveat of without waiving any argument about the constitutionality of the Electoral Count Act as it existed in 2020.¹
