AFFIDAVIT of PROBABLE CAUSE

On May 20, 2024 the George Hill Correctional Facility reported the following to the Criminal Investigation Division. Sgt May-Russell reported that on May 20, 2024 at approximately 1752 hrs. she was contacted by control room Officer S. Williams stating that there appeared to be a large amount of blood on the dayroom floor of Unit 7A. Sgt May-Russell arrived at the unit and observed inmate Kenneth Griffin running from the unit octagon with a towel on his face that was covered in blood. Griffin stated that while he was using the telephone in the dayroom he was stabbed in the face several times by an unknown individual. Due to the severity of his injuries he was transported to Crozer-Chester for treatment. He was admitted to the hospital due to the 2.5 cm long wound above his eyebrow and a long cut on the side of his nose. The Criminal Investigation Crime Scene Unit responded to process the scene. Sgt. Serody retrieved video from the dayroom, and identified Thomas Deal as the suspect. Sgt. Serody then took Deal to the medical unit, and located several small lacerations on his right hand, that appeared to be new. Thomas Deal's cell was searched and a blue uniform shirt was retrieved that was stained with what appeared to be blood. Based on the above mentioned facts, your Affiant respectfully requests the issuance of a warrant for the attached Pennsylvania Crime Code Violations.
