<p>Synopsis: This investigation is predicated upon receipt of a complaint from BRIGHTSIDE, with primary address of 5214F Diamond Heights Blvd, #3422, San Francisco, CA 94131, alleging RANDOLPH aided and abetted unlicensed activity and defrauded patients. It was reported by one of RANDOLPH's patients that on 02/27/2023 the patient discovered through social media that she was being treated by RANDOLPH's wife TR (now deceased). Photographic evidence was provided by the patient which included a picture of herself speaking to TR during one of her scheduled consults. RANDOLPH initially denied the actions, but acknowledged it was her wife consulting her patient in the photo. RANDOLPH stated due to TR's uncontrolled bipolar condition, she may have consulted with some of her patients without her knowledge. However, during BRIGHTSIDE's investigation, it became apparent that TR was seeing all her patients and had been for a long time.
