Narrative of Offense Committed

On or about the above stated date and time, the Defendant did report the alleged occurrence of a criminal act knowing the act did not occur, and the act reported was a serious or aggravated misdemeanor; or a felony

AFFIDAVIT

STATE OF IOWA, JOHNSON COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 6/16/2024 at 0011 hours, Officers were advised by dispatch that the above female was calling in to report that her ex boyfriend who is abusive was outside her residence and actively sending her threatening text messages. She also advised us that she was pregnant with the males baby. She reported she was getting text messages from the male stating he was going to hit, punch, kick, and stab her.

Officer located the male leaving the scene and began a in depth investigation about the reports being made. The male advised he had started speaking to the above female just over a week ago on a dating app. The conversation then changed over to texting the defendant. He showed us the conversation and let us read these text messages. The conversation showed he was being honest and he really did just meet this female.

The above defendant on the other hand reported she has known this male for two years and that she was pregnant with his baby. She reported he is abusive and wont leave her alone. She reported him threatening to cause harm to her. She described all of these messages taking place on snap chat. When the truth is everything took place on text messages and she deleted this. Officers saw the text messages which were being sent to her cell phone number which she confirmed to us.

After a third interview with the above defendant she stopped lying and admitted to making these false reports because she got cold feet on meeting him and no longer wanted to. She advised she didn't think officers would help so she made up this call and the events that she described. She also reported all of these fake events by calling 911. The male was detained for over an hour due to the false accusations she made.

On 6/16/2024 at 2038 I met with the defendant again and read her the Miranda Warning. After this she agreed to speak to me and again admitting to making up the accusations and calling 911 because she didn't want the male here and felt we wouldn't be able to do anything if she just called normally.
