Upon consideration of the defendant's <u>36</u> Government's Unopposed Motion to Modify Processing Rate in Light of COVID-19 Pandemic's Effect on FBI FOIA Operations, and for good cause shown, it is hereby ORDERED that the motion is GRANTED.
