Unless service is waived, proof of service must be made to the court. Fed. R. Civ. P. 4(1)(1). To avoid the finality of a mandatory dismissal of this action against the defendants, it is ORDERED that the plaintiff must, on or before August 16, 2023, either cause process to be served upon the defendants and proof of service to be filed with the Court or establish good cause for the failure to do so.
