**ROBERT CHARLES BATES**, on or about **4/2/2015**, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **MANSLAUGHTER--SECOND DEGREE**, a Felony, by unlawfully, feloniously, and willfully cause and effect the death of a human being, to-wit: one Eric Courtney Harris by an act of culpable negligence on the part of the said Robert Charles Bates to-wit: the defendant shot the victim with a Smith & Wesson Revolver which at the time he shot it he believed it to be a Taser gun, which acts were the direct and proximate cause on the death of the said Eric Courtney Harris,
