Pursuant to Sections 59-5-60 and 59-31-550, the State Board of Education (SBE) has the responsibility and duty to adopt the instructional materials used for instruction in the free public schools of South Carolina. Specific subject criteria the SBE uses for adoption are contained in the grade level education standards adopted by the State Board, and each curriculum framework, occupational education core curriculum, and other program area materials that are not addressed in the standards and supplemental curriculum frameworks.

Materials approved for adoption by the SBE are provided to school districts for further review and consideration.

Files, including formal and informal guidance, assessments, recommendations, and planning documents for instructional materials adoption from January 1, 2021, to date, are in this <u>folder</u>. None of the included files are related to identifying curriculum materials prohibited by HB 4100 (Sec. 1.105),² HB 5150 (Part 1B, Sec. 1.93),³ or HB 4300 (Part 1B, Sec. 1.82).⁴ The files are related to identifying curriculum materials based on grade-level education standards adopted by the South Carolina State Board of Education, approved state curriculum frameworks, occupational education core curriculum, and other program area materials not addressed in the standards and supplemental curriculum frameworks.
