Instead, the briefs should be submitted in printed and bound format on the above due dates. **No extensions of time will be permitted.** The covers do not need the Clerk's signature, but should follow the usual convention for colors (Ivory – Blue – Green, and Pink for excerpts). The Clerk's Office requires ten (10) printed copies of briefs and eight (8) printed copies of excerpts, if any, as well as an electronic PDF version emailed to pleadings@akcourts.gov.

6. Oral argument will be conducted in person, in Anchorage, unless otherwise announced. Oral arguments conducted before the Alaska Supreme Court are livestreamed on KTOO at ktoo.org/gavel, and are archived for later viewing at the same location.
