On 07/22/2024 at 0720 hours, I responded to 17111 E US 24 HWY regarding a lost child.

I was sent on a call about an hour before this involving a lost child who was last seen Northbound on Jennings RD towards US 24 HWY. I spoke to some of the people around the area and nobody had seen the child. I asked them all to call us if they locate him.

The child was then found by someone at the above address, which is a gas station. The employee there stated he had the child in the back with him, he had given him some food because the child said he was hungry. The employee originally thought the child was one of his regular's but when he showed up within minutes of meeting the child he said it was not his. The and he is approximately 5 years of age. He had a Nintendo Switch child's name is with him. had no shirt on, teal shorts and a pair of flip flops. I asked him if he knew where he lived and he told me yes. He pointed towards the Independence Towers. When we arrived, he said he did not live their but further down the road. After stopping at a few houses I determined he had no idea where he lived or maybe just did not want to tell me. We then went to headquarter's while my supervisor's created a facebook post to see if the community would be able to help us find the child's home.

While at headquarter's I started to look into the profile's of the Nintendo Switch, I found a "Moses" account that I tried to login to but I needed WiFi. While connecting to the city's public WiFi with it, I noticed a WiFi name previously connected labeled "BassFamily". I contacted our dispatcher's and gave them that information. Dispatch was able to locate a Moses Bass who has active utilities to the Jennings apartments in room 805.

When we arrived, told me that he did not live here inside of the elevator to get upstairs and in front of the apartment door. After knocking, Destiny Randal answered the door. I asked her "Is this your kid?" and pointed at **second**, she originally said no and began to say her kids are inside. Destiny then looked outside in disbelief. She called for Moses Bass and mentioned her knowing why the front door was unlocked when she woke up this morning.

I spoke to Moses to see why he was so nervous about coming home and he began to tell me was in trouble because the day before he urinated on the toy box. I offered him how resources and they denied wanting services. went back with the family.
