NARRATIVE The undersigned has probable cause to believe the above-named defendant on the, 9 of May 2009 at 12 20 AM at 12287 UNIVERSITY BV (Zone 22) in Orange County did

willfully and maliciously injures or damages by any means any real or personal property belonging to another including but not limited to the placement of graffiti thereon or other acts of vandalism thereto On 05/09/09, at approximately 0013 hours I responded to 12287 University Blvd, in reference to a criminal mischief On arrival contact was made with D/S Manuel Hernandez who advised the following D/S Hernandez was working an off duty detail at Knights Library (12287 University Blvd) D/S was approached by witness # 1 Michael Repass who provided a written statement about the following Mr Repass stated he was working at Knight Library when the water went out He went to the back to check the water lines and noticed a number of broken pipes spouting water behind the establishment The broken pipes followed the sidewalk and as he looked down the sidewalk and noticed two standing next to a broken pipe Repass advised a man dressed in black jeans and a black sleeveless shirt was kicking away at the pipe He stated he yelled "hey stop" and the two men ran Mr Repass chased after them-the man in the sleeveless shirt stumbled and fell and he dove on top of him, restraining him until the police arrived The second male involved returned for his friend a few seconds before the officers arrived and was handcuffed by D/S Hernandez Defendant # 1 wearing the sleeveless shirt was identified as Russell Don Sing by his Washington driver's license Defendant # 2 wearing a black shirt and blue jeans was identified as Austin A Arthur, by his Florida DL Contact was made with victim Monroe Booth property manager who stated over the phone that he will press charges and testify The defendants were placed under arrest and transported to BRC without incident A total of six backflow valves were damage, and required immediate repairs Photos of the damage were obtained and submitted into evidence At approximately 0030 hours, contact was made with Chad Atkins with the Orange County Utilities dispatch center who advised they will be sending a crew to shut off the water Repass estimated the valve repairs at \$400 00 a piece
