**AFFIDAVIT OF PROBABLE CAUSE FOR
ISSUANCE OF FELONY ARREST WARRANT FOR
ALICIA R. BRIONES**

Charges: Harboring a Fugitive
{Title 21 Section 440A}

CPC-21-5

Jason Reid, being duly sworn and upon her oath, states as follows:

1. Your Affiant is a District Attorney's investigator for the 23rd Judicial District Drug & Violent Crime Task Force, where your Affiant has been so employed since September 2023. Your Affiant has had specialized training in investigation and enforcement of laws pertaining to narcotics, violent crimes, property crimes and many other criminal activities.
2. On or about February 15, 2024, I was notified of information that Alicia Briones, a State of Oklahoma certified peace officer for the Pottawatomie County Sheriff's Office, was possibly assisting in Harboring a Fugitive from Justice, Emanuel McClain who had an active warrant from Pottawatomie County, CF-2024-00107. Alicia has a sister, Miranda Briones that was also possibly assisting in harboring the fugitive from justice. On May 30, 2024, Miranda was taken in to custody for a felony warrant from Cleveland County. During an interview, Miranda gave consent to search her cellular phone. During the search of the phone and the interview, I learned Miranda had received confidential information from Alicia in regards to harboring a fugitive, Emanuel McClain. Miranda stated Alicia had given McClain information about what vehicles undercover agents were currently driving as well as investigators location. Miranda stated Alicia told McClain, Shawnee Police officers were actively writing a search warrant for a house where McClain was staying on February 13, 2024. During the investigation it was learned Alicia had been in a relationship with McClain. When Alicia was asked about the relationship between her and McClain, Alicia stated she does not talk to him and has not talked to him in a long time.
3. On May 30, 2024 I obtained a search warrant for Alicia's Facebook account along with Emanuel McClain and Miranda Briones. During the search of the Facebook records, I learned Alicia had been in constant communication with McClain.
4. On June 25, 2024 I began an interview with Alicia along with investigator Jason Holasek. The interview took place at the Pottawatomie County Commissioners building. Alicia was read her Miranda Warning and agreed to speak to us. During the interview Alicia was asked if she had shared confidential law enforcement information to people involved in criminal activity. Alicia stated she does not remember if she had shared any information or not. At approximately 1440 hours, Alicia ended the interview and stated she needed to go pick her daughter up from driver's education. I proceeded to the parking lot where Alicia

was currently using her cellular phone. I told Alicia I was seizing her phone and I needed to take possession of it. Alicia got into her vehicle and attempted to close the door while I was standing there, striking me with the door. Alicia stated she was on the phone with her attorney and I told her she could finish the conversation. At that time a man approached and claimed to be Alicia's attorney. Investigator Holasek explained the details as to our presence and proceeded to tell Alicia we needed her phone. At that time Alicia gave us possession of the phone. The phone is currently being kept at the Task Force Office for safe keeping.

- 5.** On June 25, 2024, I was applied for and was granted a search warrant for Alicia's cell phone. I was able to get in to the phone and locate messages between McClain and Alicia dating back to December 2023. McClain was using an iCloud account, [REDACTED] It is known that McCain was using the account because of the multiple pictures he sent of himself to Alicia. While reading the messages I learned Alicia and McClain were in a romantic relationship for a period of several months. While searching the phone, there was a notification that someone was trying to remotely factory reset the phone. I denied access to the factory reset. Before I could document all the evidence I accidentally locked the phone and could not get it back open. The phone will be sent off for a forensic download to recover all evidence at a later date.
- 6.** On July 24, 2024 I took Alicia's phone to the Oklahoma Office of Attorney General and met with Agent Sean Patterson. Agent Patterson took possession of the phone to conduct a forensic download o the phone. On July 30, 2024, Captain Marcus May with the Pottawatomie County Sheriff's Office was able to obtain all of Alicia's passwords used on her county issued devices. Investigator Strand was able to locate a four (4) digit code through all of her passwords used on county devices. I contacted Agent Patterson and asked him to try the code [REDACTED] Patterson told me that code was able to unlock the device so he could continue with the forensic download.
- 7.** On August 1, 2024 I received the forensic download of the phone from Agent Patterson. I spent several days going through the data on the phone. The text conversation between Alicia and McClain occurred from December 19, 2023 to May 13, 2024. There are gaps in the chats I have logged on this affidavit. The gaps consist of text making small talk throughout the day. There are well over 1,000 texts recovered between McClain and Alicia.
- 8.** On April 9, 2024 McClain text Alicia and asked who drives a white charger. Alicia responds back by telling McClain "the DA Task Force". The Task Force has a white charger that Investigator Williams was currently driving and running surveillance on McClain at that time.

9. On April 10, 2024 a probable cause affidavit and warrant request was filed for McClain. On April, 11, 2024 McClain told Alicia through text that he had a warrant. See text conversation below dating April 10, 2024 to May 1, 2024. Several messages between McClain and Alicia have been left out of this affidavit due to not being pertinent to the case. (All times are Central Standard Time, CST)

10. April 11, 2024 @ 1443 CST

McClain: I got warrants

Alicia: Do what!

McClain: But my probation is completed

Alicia: Walk thru. For that new charge

Alicia: Let me look it up

McClain: They Charged me w two different shits

McClain: Aggravated assault and assault w deadly

Alicia: Huh ... I think I seen him come in and get the stuff signed.

Alicia: U can beat that especially if he don't show up to court....

Alicia: Wonder what his charges are

Alicia: How much is the bond

McClain: Idk

Alicia: Lemme look

McClain: He got charged w domestic abuse on minor

Alicia: But it needs to be tape in first degree

Alicia: Rape

McClain: Smh

Alicia: Imma call Shawnee n report that and what not

Alicia: If they don't do anything I'll file myself

Alicia: Delete these damn text bc clearly someone reading the mfers

McClain: Okay

Alicia: Ain't been filed

McClain: What hasn't

Alicia: Warrants I don't see any

Alicia: Imma go upstairs

Alicia: What your attorney saying

11. April 11, 2024 @ 1457 CST

Alicia: Yeah I got a warrant. U should do a walk through before court

Alicia: Like tonight Z

McClain: Man

McClain: How those shits work

Alicia: Gotta turn urself in at the sheriffs office they will tak u to the jail next door once the bond man have been there

12. On April 12, 2024, Alicia told McClain what his bond was. According to text, Alicia reached out to a bondsman for McClain and told him it would cost \$700 to bond him out if he did a walk through.

13. April 12, 2024 @ 1526 CST

McClain: I wanna lay w you tonight
Alicia: U just told me to pack yo shit
McClain: And ?
Alicia: Shit scroll up and read that shit
Alicia: That was ur 3rd personality

14. April 12, 2024 @ 1533 CST

McClain: Can I lay w yu tonight or whaa?
Alicia: Idk what I'm doing Tonight..
Alicia: Probably
Alicia: man I don't like this shit
McClain: Like what??

15. April 12, 2024 @ 2122 CST

Alicia: Wsuppp?
McClain: I'm fin kome over
Alicia: Wait until my brother leave he fiddling with tayte
Alicia: Fishing smh
Alicia: Just pulled up

16. April 12, 2024 @ 2206 CST

Alicia: Wya
Alicia I'm taking him home
McClain: Douglas
McClain: Phone was dead
McClain: Wya
Alicia: Dropping everyone off
McClain: So what you want me to do
McClain: Lmk

17. April 12, 2024 @ 2308 CST

McClain: Just let me know when you make it home

18. April 12, 2024 @ 2331 CST

Alicia: Home.
McClain: Girl I told you Kome this way yu said yu ain't want to get caught w me
in yo whip

19. April 13, 2024 @ 0012 CST

McClain: Baby here I Kome rn
Alicia: K
McClain: Leaving dominoes

20. April 13, 2024 @ 2118 CST

Alicia: I'm staying home
McClain: Okay I'm about to head back
Alicia: Trying to lock the door
Alicia: Wya
McClain: About to leave Douglas rn
McClain: Any hot water ??
Alicia: Everyone asleep u was headed this way an hour ago.
McClain: I said I was about to
McClain: Was waiting on fam
McClain: Now I'm otw
Alicia: K
McClain: Food?
McClain: Or do I need grab sumn
Alicia: Grab sumn
McClain: Okay
Alicia: Kids ate
McClain: You don't want anything?
Alicia: No I ate some cheese and crackers

21. April 14, 2024 @ 1533 CST

McClain: Man ppl pissin me off 'm fin Kome back that way
Alicia: Ok going to store
McClain: What store
Alicia: Walmart
McClain: Okay
Alicia: And then mcloud to drop tayte off.. I'll tell u when I'm headed home
McClain: Okay babe ya'll be careful

22. On April 14, 2024 at 1936 hours CST, Alicia sends an image to McClain of steaks, hamburgers and hotdogs on a grill,

23. April 14, 2024 @ 1955 CST

McClain: So you ain't say nun bout yu being home ??
Alicia: Phone died
Alicia: I text u an hour ago
Alicia: Got home like 630
McClain: And said what ?
Alicia: N sent that pic
McClain: Well I'm fin head back before the food gone
Alicia: Yeah bc these kids some animals
McClain: lol put me sumn back man
Alicia: Ain't no one eating these hot links
Alicia: They'll be more than enough if u hurry neighbors was asking what I grilled
McClain: Okay bet
McClain: Ride fin pull up in a minute or so
Alicia: Mya boyfriend leave at 9 so try to be here before 845

Alicia: Or after he leave
McClain: Ima just wait til after 9 I guess smh
Alicia: K
McClain: Koming now
Alicia: Okayyyyy
McClain: Still coming down Kickapoo
McClain: Passin yo place of employment
Alicia: K

24. April 15, 2024 @ 1135 CST

McClain: My fucking head hurts
Alicia: Mine too. And I'm horny as lol
Alicia: I'm serious tho
McClain: I'll give you sumn later
Alicia: Should of this morning
McClain: Wasn't feeling good
Alicia: I know

25. April 15, 2024 @ 1209 CST

McClain: (Sends Image of himself)
Alicia: Should of stayed ur ass at the house n ate that steak

26. April 15, 2024 @ 1640 CST

McClain: Baby when you get home will you put my clothes nk dryer
Alicia: Kids already home when you start it??
McClain: This am

27. April 15, 2024 @ 1703 CST

McClain: Who posted on granny stevens
McClain: The old store on highland
Alicia: Who is that
Alicia: I see him... stay inside lol
McClain: Which punk Nigga is that

28. April 15, 2024 @ 1950 CST

McClain: (McClain sends image of himself)

29. April 15, 2024 @ 2049 CST

McClain: Waitin on ride
Alicia: Lmk when it gets there
McClain: Here

30. April 15, 2024 @ 2121 CST

Alicia: Just say u ain't coming home
McClain: I'm koming home

31. April 15, 2024 @ 2212 CST

McClain: I'm on my way rn
McClain: Ion got no inhaler tho missy (dog) kant sleep w us tonight
Alicia: Ryanah has one
McClain: Okay
McClain: Hot water?
Alicia: Running out as we speak 4 th shower lol
McClain: Man hahahah

32. April 16, 2024 @ 0812 CST

Alicia: Babe I need some more weeny
Alicia: Idk what is wrong with me
McClain: Im fin get picked up. I need inhaler
Alicia: K
McClain: just found one fin go pick it up
Alicia: Shut doors
McClain: Yes ma'am
Alicia: Lmk when u leave so I can activate my cameras
McClain: Okay I will

33. April 16, 2024 @ 0843 CST

McClain: Leaving now babe
Alicia: Kay

34. April 16, 2024 @ 1239 CST

Alicia: I was about to bring you food I'm back now
McClain: Damn it
Alicia: Threw it away.

35. April 16, 2024 @ 2124 CST

Alicia: Delete our shit
McClain: It' already deleted
Alicia: This one we texting

36. April 17, 2024 @ 1153 CST

37. In reference to Steven Gregory bonding out of jail

38. McClain: So did he bond out or wha?
Alicia: Checking I think the DA is cutting him a deal for telling on u
McClain: Probably
McClain: I'm ready to come home, I'm done being around here
McClain: (Sends image of himself)

39. April 17, 2024 @ 1407 CST

Alicia: These ppl back I swear if you didn't have a warrant lol I want to take my gun belt off so bad

Alicia: (Alicia sends image of wet bed sheets with caption "all I said was good girl")

Alicia: da declined to file charges on him. Bc they want him to tell on u

Alicia: (Alicia sends image from jail website of decline to file)

Alicia: They want u bad

Alicia: We home

McClain: My brother here you want me to kome??

McClain: I'm otw rn getting in car

40. April 20, 2024 @ 1133 CST

McClain: (Sends image of himself to Alicia)

41. April 20, 2024 @ 1533 CST

Alicia: (Alicia picks up McClain from unknown location. Sends text to McClain, "Get in back jack")

42. April 22, 2024 @ 1426 CST

Alicia: My mom is coming to house at 330

McClain: Oh I'm already at my moms

Alicia: Stupid nigggg

McClain: Lol

Alicia: Whole time I could of activated my cameras

Alicia: I gotta start locking my door lol House all open haha

McClain: My bad I thought you knew I was going to b leaving earlier

Alicia: U never said anything

Alicia: U said I'm about to cook eggs Then mia then not answering my calls lol

43. April 22, 2024 @ 1426.2225 CST

Alicia: I didn't do your clothes

McClain: left son as I woke back up

44. April 25, 2024 @ 2154 CST

Alicia: I may or may not have spent ur bond money on a pool table

McClain: Go ahead

McClain: That one yu showed me?

45. April 26, 2024 @ 1313 CST

McClain: This white man just pulled up on Drew's and took a picture of me

Alicia: Well u got warrants

Alicia: White truck????

McClain: No like a grey honda

Alicia: Yeah they probably about to pull up

Alicia: They was on a warrant sweeps earlier

McClain: Yeah I pushed off on a bike

McClain: I'm by bowling alley

McClain: (McClain sends image of himself to Alicia)

46. April 26, 2024 @ 1652 CST

McClain: (McClain sends image of himself at bowling alley to Alicia)

47. April 26, 2024 @ 1704 CST

Alicia: (Alicia sends image of her in PCSO uniform to McClain)

48. 4-27-2024 @ 2006 CST

Alicia: Imma need u to come eat this butt

McClain: Wild hahahaha ha

49. On April 30, 2024 I observed two females leave a house on Ridgewood and Douglas where McClain had been known to stay. I followed the two females and made contact with them approximately 3 blocks from the residence. While questioning the females, I observed McClain walking down the street. The two females yelled for McClain to run because I was the police. McClain fled on foot and was located in a backyard by Shawnee Police. McClain was taken in to custody and transported to the Task Force office for questioning. Investigator Holasek conducted an interview with McClain. McClain was booked in the Pottawatomie County Public Safety Center for his active warrant. McClain bonded out shortly after.

50. May 1, 2024 @ 0718 CST

Alicia: Where is the money u said u had put back

McClain: It was on me but guess I through it when I emptied my pockets

Alicia: They get ur phone?

McClain: Went to jail w 11\$ in my pocket

McClain: Hell nah

McClain: No catching me w it

Alicia: Task force been watching u and u walking around like u ain't got a warrant

Alicia: Who was the girls

McClain: Some bitches walking they the ones said Zeus run

Alicia: One told the deputy u was her man
McClain: Hell nah they didn't nigga
Alicia: Soule put that over the radio
Alicia: Soule said one with shorts on identified as Zeus girlfriend
McClain: Lmaoooo he wild for that
Alicia: Soule is female deputy

- 51.** During the time of McClain's warrant from April 10, 2024 until he was arrested on April 30, 2024, Alicia was allowing McClain to stay at her residence. Alicia was supplying McClain with food and water as well as hot showers and a place to do his laundry. Alicia has surveillance cameras on her residence and would turn them off while McClain was staying at her residence. Alicia was terminated from the Pottawatomie County Sheriff's Office on June 25, 2024 for an unrelated incident.
- 52.** On August 5, 2024 I went to the Pottawatomie County Court Clerk Office to verify the warrant for Emanuel McClain case number CF-2024-107, was active and valid on April 10, 2024. The warrant was recalled on April 18, 2024 for incorrect spelling of McClain's name. The warrant was re-issued on April 19, 2024.
- 53.** Based upon the above facts and authority, your Affiant would respectfully request this Honorable Court make a finding of probable cause to believe that the above referenced individual has committed the crimes as specified above, namely Harboring a Fugitive, a FELONY, 21 O.S. § 440(A). and as a result issue a warrant for her arrest.
