On 08/27/2024 at approximately 1500 hours I, Officer Moseley responded to All About Kidz at 387 W Broadway St. in response to an open DCF case from the day prior in which a 6 year old girl, [REDACTED] was left on the daycare's bus alone in the heat for an extended period of time the day prior, 08/26/2024. Through DCF's investigation and my own investigation, it was determined [REDACTED] was left sleeping on a daycare bus, which was turned off and unattended, for a period of one hour and two minutes in the parking lot of All About Kidz. The driver, Barbra Ledbetter, did not check the bus after arriving to the daycare and letting the kids off. Her job duty requires her to physically go to the back of the bus and visually check the seats, which she did not do. She then signed a log stating she checked the bus. [REDACTED] was asleep in the back and unaware everyone exited. She later woke up realizing she was very hot and had trouble breathing. She began banging on a window. Surveillance video shows a passing parent walking by and noticing [REDACTED]. The video showed [REDACTED] was alone on the bus for one hour and two minutes.

[REDACTED]'s [REDACTED] completed a written statement and is willing to press charges.

I established probable cause to arrest Ledbetter for F.S.S. 827.03 (2d) Neglect of a Child Without Bodily Harm. She was secured using double-locked handcuffs which were checked for proper fit and searched by Officer Selmer. I transported Ledbetter to the Seminole County Jail in my marked patrol vehicle.



