**IDENTIFICATION OF LATENT FINGERPRINTS**

On 03/20/98 I was called to 3623 12th Street SE to examine the crime scene for latent fingerprints. I lifted five latent lift cards, Detective Stoelk lifted four latent lift cards for a total of nine latent lift cards. These nine latent lift cards contained four identifiable latent fingerprints made by (V) Ms. Harriet Thompson. One identifiable palm print (lifted from the top of the toilet) was made by the right palm of (O) Mr. Christopher Casey Rodrigues), and four latent prints of value.

On 03/21/98 I examined the other surfaces in the crime scene for latent prints. I lifted one identifiable latent fingerprint from the surface of a large vase (knocked over in the struggle) right next to three red stains, which appear to be made by three fingers in blood. This latent fingerprint was made by the number 3 (right middle) of Mr. Jesse Lee Johnson and no other person.

On 3/25/98, at 1600 hours, the Crime Lab received from the Evidence Locker the following items:

1. A sealed brown paper evidence bag marked 5E for A latent fingerprint evaluation.

An examination revealed several pop cans in A plastic bag, four identifiable fingerprints and eight latent prints of value. The latent fingerprints were photographed. The latent fingerprints developed on the

pop cans were compared against the known persons known in the case, with no identifications made.

2. A sealed brown paper evidence bag marked 12 for A latent fingerprint evaluation.

An examination revealed A black piece of plastic with no latent fingerprints of value.

3. A sealed brown paper evidence bag marked 13E for A latent fingerprint evaluation.

An examination revealed one broken off knife blade with A latent shoe sole impression. The latent shoe sole impression was photographed.

4. A sealed brown paper evidence bag marked 14E for A latent fingerprint evaluation.

An examination revealed one set of keys with no latent fingerprints of value.

5. A sealed brown paper evidence bag marked 15E for A latent fingerprint evaluation.

An examination revealed one silver plastic card hold and contents, including ten dollars, one five dollar bill and five one dollar bills. A bright clear identifiable palm print was developed on the five dollar bill. This identifiable palm print was made by the left palm of Mr. Jesse Lee Johnson and no other person.


The palm print developed on the five dollar bill is one of the clearest, brightest ninhydrin prints that I have ever developed on circulated paper money. I felt that the reason for this was that the print was in blood. I did an experiment using circulated five dollar bills. One five dollar bill was held tightly in my hand for two minutes and treated with ninhydrin solution. No latent fingerprints were developed on it. The other bill was marked blood. I put several drops of cows blood on my hand and held the five dollar bill tightly for two minutes and treated the five dollar with ninhydrin solution. A clear, bright palm print was developed on this five dollar bill.

This experiment confirmed my belief that the print was in blood.

6. A sealed brown paper evidence bag marked 20E for A latent fingerprint evaluation.

An examination revealed one black leather purse and contents with no latent fingerprints of value.

7. A sealed brown paper evidence bag marked 21E for A latent fingerprint evaluation.

An examination revealed one medicine bottle with three pills with no latent fingerprints of value.

8. A sealed brown paper evidence bag marked 25E for A latent fingerprint evaluation.

An examination revealed one yellow key FOB with no latent fingerprints of value.

9. A sealed brown paper evidence bag marked 27E for A latent fingerprint evaluation.

An examination revealed one green wallet and contents with one shoe sole impression and two latent fingerprints made by the victim.

10. A sealed evidence bag marked 60E for A latent fingerprint evaluation.

An examination revealed one plunger with no latent fingerprints of value.

All of the developed latent fingerprints were photographed.

The evidence was returned to the Evidence Locker.

**NARRATIVE**

At approximately 1000 hours, on 5/5/98, I contacted (O) Donohue. I had contacted and interviewed Donohue approximately two weeks prior to this contact. At the time of the initial contact, Donohue had a female's ring attached to one of the belt loops of his pants. I had obtained the ring and taken a photograph of it to show to (D) Thompson's mother. The deceased's mother, Eva Corbin, had positively identified that ring as having belonged to her daughter. In my initial contact with Donohue, he had indicated he had obtained the ring only one to two days prior to my contacting him. In my second contact with Donohue on 5/5/98, he maintained that he had obtained the ring from another individual just a day or two prior to my first contact with him. Donohue refused, however, to identify the individual that provided the ring to him. In questioning Donohue regarding receipt of any jewelry from Johnson that was purported to have come from a deceased female, Donohue said that Johnson had never made any statement like that to him. Donohue did indicate that he has received some jewelry items from Johnson, but refuses to disclose who he has gotten rid of them to. Donohue indicated in my first contact with him that he had sold items of jewelry to a second hand store located on Hood

Street in Salem, OR. In contacting that business, they did not have any paperwork that indicated the purchase of any jewelry items from Donohue.

It is unknown what jewelry items Donohue may have received from Johnson, as well as he may have received them, as Donohue is not very cooperative in providing information regarding Johnson or jewelry.

At approximately 1530 hours, on 5/5/98, I contacted Robert Naylor. Two items of jewelry that I had obtained had been identified as having come from Naylor. The first item was a locket obtained from Anastasia Pitts, that was positively identified by Diana Kozad as having belonged to the deceased. Pitts had told me that she received the locket from Naylor. The second item was a woman's ring that I obtained from Stacey Satter. Satter had told me she had received the ring from Naylor.

I showed Naylor photographs of the locket and the ring. Naylor acknowledged having given Pitts the locket, but indicated he wasn't sure exactly where he obtained it from. Naylor denied giving a ring to Satter and indicated if she stated she got the ring from him, then she had probably taken it without his knowledge. In talking to Naylor, he said it was possible he got both items of jewelry indirectly from Jesse Johnson. Naylor stated he is familiar with Jesse Johnson and that he had met him through a mutual friend of theirs by the name of Vicki Free. Naylor could not provide a specific time frame that he received the ring or the locket.

As previously stated, the locket had been identified by Diana Kozad as belonging to the deceased. The ring that I obtained from Satter had been positively identified by the deceased's mother, Eva Corbin, as having belonged to her daughter.

Investigation continues.
