04/19/2022		MINUTE ORDER: The court has reviewed the parties' <u>22</u> Joint Status Report, including Plaintiff's request that the court order the Department of State and ODNI to process document requests at a rate of 500 pages per month. "Courts have broad discretion to determine a reasonable processing rate for a FOIA request." <i>Colbert v. FBI</i> , No. 16-1790, 2018 WL 6299966, at *3 (D.D.C. Sept. 3, 2018) (collecting cases). "Courts in this district have exercised that discretion in somewhat different ways depending on the facts and posture of the case," taking into account agency resources and a presumption that the agency is operating in good faith. <i>Harrington v. Food &amp; Drug Admin.</i> , No. CV 20-1895, 2022 WL 179330, at *3 (D.D.C. Jan. 20, 2022) (same). Here, Defendants contend that their processing rates are tied to limited resources and are consistent with processing rates in other FOIA cases, and Plaintiff provides no evidence of bad faith or argument for why expedited processing is warranted. Consequently, based on the facts presented, the court finds no reason to order the Department of State or ODNI to change their proposed processing rates of 300 pages per month and 100 pages per month respectively, and hereby ORDERS that they process Plaintiff's request at least at those rates.
