(U) EXPRESSED OR IMPLIED THREAT: University of Michigan, MI

(CUI) On 09 Feb 23 at 1600L, four Naval Talent Acquisition Group (NTAG) Heartland recruiters were attacked by protestors on the University of Michigan's Ann Arbor campus during a job fair event. A group of protestors stormed the recruiters' stand/booth and sprayed red watercolor on them. The protestors were immediately arrested by local law enforcement (LLE). At 1700L, another group of protestors appeared with air horns and anti-military fliers, chanting "you have blood on your hands". This second group of protestors was also arrested. There were no reports of injuries to the recruiters. Recruiters provided LLE with a police report. At 1900L, all Navy recruiting staff exited the scene.

Subject: NTAG Heartland Protest/Assault update

Good afternoon Gentlemen,

I wanted to push some clarifying information that I've received from University of Michigan Police Department (UMPD) about what transpired yesterday at UM's career fair. I was informed that the career fair was comprised of mainly government entities, such as the U.S. Navy, Oakland County Sheriff's, IRS, Army National Guard, NSA and the Social Security Administration to name a few. It was reported that activists affiliated with the "StopCampGrayling" group were placing flyers (attached) on the desks of employers while their desks were left unattended. Although these flyers never made it to the NAVY desk they were left on the Oakland County Sheriff's desk, as well as the NSA's desk. Shortly after discovering the flyers, two females began squirting an unknown substance, red in color on multiple government officials, to include Navy personnel while yelling "You have blood on your hands". The two females were apprehended by the Oakland County Sheriff and the IRS. Approximately 30 minutes following the arrest, a group of roughly 16 protestors rallied outside the facility protesting and demanding the release of the two females while also yelling anti-government rhetoric. According to UMPD, the protest lasted about 30 minutes and then dispersed. The two females in custody are charged with multiple assault charges according to UMPD. UMPD stated that they do have officers posted at these types of events because they are open to the general public. UMPD also stated that they will most likely add additional officers to better support

future career fair events. I will be standing by to answer any additional questions you may have.
