**IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:**

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **TYRONE BERRY**, hereafter styled the Defendant, heretofore on or about **June 6, 2019**, did then and there unlawfully, knowingly receive a benefit, namely, CASH MONEY, from participation in a venture that involved the trafficking of B.M., a person younger than 18 years of age, hereinafter called the Complainant, in which the Complainant was caused to engage in and become the victim of conduct prohibited by Section 43.25 (Sexual Performance by a Child) of the Texas Penal Code and Section 43.04 (Aggravated Promotion of Prostitution) of the Texas Penal Code.

Before the commission of the offense alleged above, on May 2, 2006, in Cause Number 1019634, in 180th District Court of Harris County, Texas, the Defendant was finally convicted of the felony offense of Sexual Assault of a Child.

**Probable Cause**

Affiant C. Estrada is a certified Peace Officer with the Harris County Sheriff's Office, Human Trafficking Division. Your Affiant has reason to believe and does believe that Tyrone Berry, a black male with date of birth May 24, 1966, referred to as the Defendant, identified by previous Harris County Booking Photo, SPN# 01089196, committed the felony offenses of 2 counts of Trafficking of Person, Compelling Prostitution and 2 counts of Sexual Assault of a Child reported on June 6, 2019, in Houston, Harris County, Texas.

**Affiant bases her beliefs on the following:**

On 09/10/2024, I, Deputy C. Estrada, unit 12i28 was tasked to conduct a follow up investigation on HCSO incident 1906-04896, involving Tyrone Berry, DOB: 05/24/1966, SPN: 01089196, hereafter styled Defendant, due to the initial investigator R. Bilinovich, whom Affiant knows to be credible and reliable, being retired. I reviewed HCSO incident #1906-04896, and learned that on Friday, June 14, 2019, B.M. was originally found at 13003 SH 249 known as (Walmart).

B.M. informed Affiant she was placed into a group home, but ran away from the group home around May 2019. B.M. informed she was dropped off at the Walmart by a black male, who was later identified to be the Defendant. B.M. walked towards a passerby in the parking lot where she requested for help. B.M. was transported to the hospital where she was met by investigator Bilinovich. Investigator Bilinovich was called out to Willowbrook Methodist Hospital involving a runaway juvenile, B.M., hereafter styled Complainant, possibly being sex trafficked. Investigator Bilinovich met with the Complainant and obtained the following statement from her: Complainant stated that she was forced to "work" for food by a guy she knows as Tyrone, the Defendant.

The Complainant stated the Defendant worked at a hotel located near a freeway that had a sign advertisement "\$39.99" a night. The Complainant described the Defendant as a black male, older, bald head, and works the lobby. The Complainant stated that the Defendant would set up the "dates" and instruct her what to do. Affiant knows through training and experience a "date" is an encounter between a prostitute and a "john"/ buyer for the purposes of performing sexual acts in exchange for money, with the female. B.M. stated if she made enough money the Defendant would give her food. The Complainant stated she wasn't making enough money for the Defendant so he dropped her off at a Walmart in a red minivan. The Complainant stated the last time she was on a date was that morning of Friday, June 14, 2019.

Affiant reviewed a supplement report, under HCSO incident #1906-04896, written by investigator Bilinovich. Affiant learned that on Monday, July 15, 2019, interviewed and obtained the following statement from her: the Complainant stated that she ran away from the placement home on or about June 8, 2019. The Complainant stated on or about the third day, a friend dropped her off at a hotel she believes

was called the north villa hotel. The Complainant stated that while she was at the hotel, she met an employee, the Defendant also knows as "big mike." the Defendant told her to stay in the lobby and he would take care of her when he got off work. the Complainant stated the Defendant took her to a recording studio, where she met Otis Berry also known as "big face Tulu " the Complainant stated she would have sex with the Defendant's friends and family. The Complainant stated she felt the Defendant was getting paid because she never saw any of the money. The Complainant stated she was provided drugs while at the recording studio. The Complainant stated she had sex with more than 20 men while she was at the recording studio and the Defendant's house. B.M. reported that she was brought by this Defendant, Tyrone Berry, to a home and forced by Tyrone Berry to have sex with his brother, Paul Berry

On October 8, 2019, investigator Billnovich arrived to the north villa hotel located at 16510 North FWY, where B.M. mentioned she was with the Defendant. Investigator was able to make contact with the Defendant while requesting for records. Investigator Bilinovich stated the Defendant confirmed speaking to the Complainant On October 22, 2021, Complainant b. m. was presented a photo line-up that included a photo of the Defendant The Complainant positively identified the Defendant.

Based on the above, Affiant believes and has reason to believe that Tyrone Berry, a black male with date of birth May 24, 1966, referred to as the Defendant, identified by previous Harris County Booking Photo, SPN# 01089196, committed the felony offenses of 2 counts of Trafficking of Person, Compelling Prostitution and 2 counts of Sexual Assault of a Child reported on June 6, 2019, in Houston, Harris County, Texas.
