The Court notes that corporate entities may not represent themselves in federal court proceedings. See Lennon v. McClory, 3 F. Supp. 2d 1461, 1462 n.1 (D.D.C. 1998) (citing Rowland v. Cal. Mens Colony, 506 U.S. 194, 201–02 (1993)). Plaintiff's counsel shall forward a copy of this order to Plaintiff through the means described in the withdrawal motion. Counsel shall also indicate in the scheduled September 10th joint status report whether it received any communication from Plaintiff in response to this order or otherwise.
