

WARNING

It is a felony for anyone to sign any initiative or referendum petition with any name other than his own, or to knowingly sign his name more than once for the measure, or to sign such petition when he is not a qualified elector. Under Idaho Code §34-1803B, a petition signer may remove their name from a petition by crossing it out with a single line or by presenting a signed statement to the county clerk asking for removal prior to signature verification.

DECRIMINALIZE CANNABIS NOW

**REQUESTED SHORT BALLOT TITLE:**  
INITIATIVE DECRIMINALIZING CANNABIS, CALLED "MARIJUANA" OR "MARIHUANA" AS DEFINED IN TITLE 37-2701(U), FOR PERSONAL USE, HOME CULTIVATION, AND LIMITED PERSONAL PRODUCTION.

**REQUESTED LONG BALLOT TITLE:**  
AN INITIATIVE RELATING TO CANNABIS, CALLED "MARIJUANA" OR "MARIHUANA" AS DEFINED IN TITLE 37-2701(U); AMENDING TITLE 37, IDAHO CODE, BY ADDITION OF A NEW SECTION, 37-2752, CREATING EXEMPTIONS TO TITLE 37 FOR POSSESSION, PRODUCTION, AND CULTIVATION OF CANNABIS FOR PERSONAL USE. THIS INITIATIVE DOES NOT SUPPORT PRIVATE OR COMMERCIAL SALE OR RESALE OF CANNABIS OR CANNABIS DERIVED PRODUCTS, NOR DOES IT SUPPORT TRANSPORTATION OF CANNABIS OR CANNABIS DERIVED PRODUCTS THAT EXCEED ONE OUNCE OF PLANT OR 1000MG of THC.

Be it enacted by the People of Idaho:

**SECTION 1. That Title 37 Chapter 27, Idaho Code, be, and the same is hereby amended by the addition thereto of a NEW SECTION, to be known and designated as Section 37-2752 and to read as follows: 37-2752 EXEMPTIONS – EXEMPTIONS FOR POSSESSION, PRODUCTION, CULTIVATION – PENALTIES.**

**37-2752A MARIJUANA.**

(1) Possession, production, or cultivation of Marijuana or Marijuana-infused products are exempted from penalties imposed by this Chapter if: (a) such Marijuana is for personal use and not for sale or resale; (b) is not consumed in any public or open setting; (c) is in the possession of a person who is at least 21 years old.

(2) Nothing in this section shall be construed to allow private or commercial sale or resale of any controlled substance nor transportation in quantities that exceed one ounce of plant or 1,000 mg of THC in other Marijuana derived or infused products.

**SECTION 2. That Section 37-2734A, Idaho Code, be, and the same is hereby amended by the addition thereto of a NEW SUBSECTION to be known and designated as Subsection 37-2734A(4), Idaho Code, and to read as follows:37-2734A(4). Except as provided for in I.C. 37-2752A.**

**SECTION 3. SEVERABILITY.** The provisions of this initiative hereby declared to be severable if any provision of this initiative the application of such provision to any person or circumstance is declared invalid for any reason, such declaration shall not affect the validity of the remaining portions of this initiative.

**Funding Statement:** None.

**Fiscal Impact Statement:** Passage of this initiative will result in a net increase to police budgets as they will no longer be spending money to prosecute or incarcerate people in Idaho for using plant-based and derived remedies that are legal in nearly every surrounding state.
