Dear Mehreen Rasheed:

Thank you for writing to Butler County with your request for documents pursuant to the Pennsylvania Right-to-Know Law (“RTKL”).

Your request of November 4, 2022 (a copy is attached), seeking electronic communications and related records between Commissioner Osche or Commissioner Geyer and various named individuals and entities, is granted in part and denied in part.

The County has identified 43 responsive public records, which we are providing here (see attachment). Some of those records contain, we believe, personal cell phone numbers and/or personal email addresses that are exempt from disclosure under Section 708(b)(6)(i)(A) of the RTKL. These have been redacted in accordance with Section 706 (“If the information which is not subject to access is an integral part of the public record..., the agency shall redact from the record the information which is not subject to access, and the response shall grant access to the information which is subject to access”).

Additionally, the County withheld 2 records that pertained to a complaint submitted to an agency, pursuant to Section 708(b)(17)(i) of the RTKL.

You have a right to appeal this denial in writing to Executive Director, Office of Open Records, Commonwealth Keystone Building, 400 North St., 4th Floor, Harrisburg, PA 17120.

If you chose to file an appeal, you must do so within fifteen (15) business days of the mailing date of this response. Please note that a copy of your original Right-to-Know request and this denial letter must be included when filing an appeal. The Law also requires that you state the reasons why the record is a public record and address the reasons given by the County for denying your request. Visit the Office of Open Records Web Site at <http://openrecords.state.pa.us> for further information on filing an appeal.

Dear County Election Officials:

As you are undoubtedly aware, there has been a large amount of litigation surrounding the November 3, 2020 general election. While some of these cases have been disposed of, others continue to work their way through various courts. Further, you may also be aware that Pennsylvania is a member of the Electronic Registration Information Center (“ERIC”). ERIC membership assists in improving the accuracy of Pennsylvania’s voter rolls and in performing voter list maintenance activities. As part of its membership in ERIC, Pennsylvania is participating in the Voter Participation Project to assist in identifying any voters who may have cast “improper votes” in the 2020 general election. A review of records for the 2020 general election in conjunction with the Voter Participation Project is currently ongoing. To complete this project, information is required from some counties that has not yet been provided despite requests by the Department of State (“Department”).

We are approaching the end of the 22-month document retention requirement for records pertaining to federal elections. *See* 52 U.S.C. § 20701. However, the statute of limitations for federal crimes related to improper voting is five years. In addition, Pennsylvania has a two-year statute of limitations for casting improper votes in an election. Given the Department’s current review in connection with the Voter Participation Project, **the Department strongly recommends that all counties continue to maintain all voting records pertaining to the 2020 general election.**

Further, **if your county is involved in any currently pending cases relating to the 2020 election**, all those records should be maintained, notwithstanding any contrary document retention policies your county might have. Even if your county is not currently involved in any such litigation, given the factors mentioned above and in an abundance of caution, we believe it would be prudent to continue to retain 2020 general election records for the time being and request that you do so.

As always, you should consult with your solicitor on this specific and any other document retention issues. Thank you for your anticipated cooperation. Please do not hesitate to contact me with any concerns.

Please provide us updates each meeting regarding what actions you have taken to resolve the issues you addressed in the Election Review Commission Report.

As a reminder, you recommended:

While the Commission submitted many recommendations, the following are the most significant.

1. Provide voters with a "Right to Know" guide explaining all four methods of voting in detail: Election Day, Mail-In, Early In-Person, and Provisional along with the potential consequences associated with each method
2. Change the deadline for mail-in and absentee ballots from 7 days prior to the election to at least 14 days prior.
3. Reverse the provision in Act 12 that allows for surrendering mail-in/absentee ballots at the polls. The Commission recommends only the use of provisional ballots if this act is allowed.
4. Format the poll books as was done in the 2020 Primary using grayed out boxes and no signature lines for voters whose ballots had been returned by mail.
5. Complete a more standard and transparent audit using third parties rather than election staff. Audit a select number of precincts, representative of voter demographic profile, from registrations through tabulation.
6. Adopt legislation that governs changes in election procedure and/or code during a state of emergency that requires approval of both executive and legislative branches with well-defined communication guidelines.
7. Develop a statutory disaster and business continuity plan for elections during a public emergency. The plan should be widely shared and implemented.
8. Adopt and audit a security framework and compliance standards for technology.
9. Implement more robust testing of tabulation software in particular as it relates to the use of data USB flash drives, as Butler County officials experienced a tabulation error that could have affected tabulation totals had the reconciliation process not identified the problem prior to certification of results.

We've been asking for # 5 & 8 for since May 2021. We've seen nothing thus far.

Also, your recommendations to the Bureau of Elections:

Scan and attach applications for mail-in ballots to the voter's record for verification and reference purposes.

Provide voters with a "Right to Know" guide explaining all four methods of voting in detail: Election Day, Mail-In, Early In-Person, and Provisional along with the potential consequences associated with each method.

The Commission supports the County's decision not to use drop boxes because of statutory requirements that indicate a voter may only return "their own" ballot in order to verify the "one person/one vote" process, and to prevent ballot harvesting.

Continue the use of a ballot drop-off station in the Government Center lobby and consider the use of staffed Satellite Election Offices in high density areas which provide a more convenient location for returning a ballot.

Continue the use of Election Bureau extended hours leading up to the election to allow voters more options for returning their ballot.

Establish a procedure for counting Mail-In ballots received in the Bureau of Elections on election day in order to avoid a duplicate vote by a voter who may have surrendered an "inactive" ballot at the polls and voted regularly.

Make the mail-in vote tabulation process more accessible / visible to the public through use of

observation windows and or live video feed.

Identify clearly on the website whether the posted results are complete and / or certified.

Convene an advisory group to investigate and consider the use of electronic poll books for accuracy, efficiency, and voter verification purposes.

Sufficient staff must be trained and available to print and proof poll books in the compressed timeframe that ensures that voters who requested and / or returned a mail-in ballot are recorded and easily identified.

Complete a more standard and transparent audit using third parties rather than election staff to improve voter confidence. Audit a select number of precincts representative of voter demographic profile from registrations through tabulation to allow for identification of irregularities and recommendations for procedural improvements that protects the integrity of the election. This does not preclude participation in Risk Limiting Audits, or the statutory two percent audit, but rather enhances the local audit process.

Provide an expanded analysis of election results; historical data comparisons; or a Bureau of Elections Annual Report as a tool to improve trust.

Are any of these even in the works? Does the Bureau of Elections oversee you or do you oversee the Bureau of Elections? It looks like the former to me.

Most of these are good recommendations, but using electronic pollbooks is an absolutely disastrous idea - we keep telling you any devices that can be connected to the Internet can & will be used for committing voter fraud (this is why ES&S does not want anyone to inspect their garbage, hackable-by-11-year-olds voting scanners & ballot-marking-devices, and electronic pollbooks).

It'd be nice if you were to reach out to us for advice, as we have knowledge on how horrible these devices (& mail-in ballots) are when attempting to conduct a fair, legal election. But all of us that show up demanding a full forensic audit are convinced you do not care about the voters of Butler County, who you swore an oath to serve with fidelity.

And of course, none of your recommendations are of any good if you refuse to act on them. Did you even bother to read any of the many Left-wing articles or watch the videos I sent all of you about how vulnerable ALL of these electronic voting machines are?

Just one more reminder that it is your duty to serve the citizens of Butler County with fidelity, as you swore in your oaths of office. We trusted you to live up to that oath & I do not see that you are taking that oath seriously enough.

I suggest you read the Pennsylvania Constitution, the United States Constitution & research the Doctrine of the Lesser Magistrate in order to fully understand your role & duty to your fellow citizens.

The Ranking Members of the Senate Rules, Intelligence, Armed Services, and Homeland Security Committees are requesting information about the security of voting systems

WASHINGTON – U.S. Senator Amy Klobuchar (D-MN), Ranking Member of the Senate Rules Committee with oversight jurisdiction over federal elections, sent a letter to the country's three largest election system vendors with questions to help inform the best way to move forward to strengthen the security of our voting machines. In the U.S., the three largest election equipment vendors—Election Systems & Software, LLC; Dominion Voting Systems, Inc.; and Hart InterCivic, Inc.—provide the voting machines and software used by ninety-two percent of the eligible voting population. However, voting and cybersecurity experts have begun to call attention to the lack of competition in the election vendor marketplace and the need for scrutiny by regulators as these vendors continue to produce poor technology, like machines that lack paper ballots or auditability.

RALLY FOR UNITY Views aired at Diamond Park event

Hundreds gathered during a sunny Sunday afternoon in Butler's Diamond Park in the hopes of making their voices heard.

Attendees milled about in patriotic apparel, some featuring the American flag while others appeared in derogatory messaging about President Joe Biden. A few individuals donned tactical equipment and hol-

stered pistols.

"I'm hoping this opens some eyes," said Tyler Campbell of Cabot.

Campbell said he took a particular interest in the results of the 2020 election, and he believes there should be an audit, a common theme of the event.

"My family is split in half on this," he said. "I'd like for my family to be on one side."

There were food trucks, shirt ven-

dors and other activities to spend time with between speakers and lining the street with signs. Many of the signs demanded to know "the truth" about the election.

Zach Scherer of Chicora helped his organization, the Butler PA Patriots, introduce speakers throughout the evening.

Scherer claims there is evidence

showing discrepancies in Butler County election results. He said he and his colleagues have spoken at Butler County commissioners meetings, and commissioners have disregarded their requests for an audit of the county's election results.

"There were issues across Butler County," he said.

There have not been any proven accounts of widespread voter fraud in Pennsylvania.

Scherer said even though an audit may not change much in Butler County, which voted heavily in favor of Trump, it may impact some of the local races, and it would set a precedent for other counties wanting similar audits across the state.

With traffic flowing full-strength past the downtown location, the messaging received many honks of approval every five seconds or so. Some visitors came from Allegheny County, like Victoria Hall and Cindy Haley, both of Gibsonia.

"We need to know there is unity," Hall said. "We need the strength in numbers."

Both women were particularly concerned with the government's deci-

sions regarding the COVID-19 pandemic. Haley said she didn't attend the event for former President Donald Trump's sake.

"This has nothing to do with Trump," Haley said. "It has to do with constitutional rights."

Though topics ranged amidst the speakers, the two heavily favored topics included the audit on the 2020 election results and the mask mandate in

schools issued by state Acting Secretary of Health Alison Beam.

Bill Halle, a school board member for the Butler Area School District, said he and his colleagues have taken a pro-choice approach, but other schools have not.

"If the school district is choosing to do that, they are choosing to do that of their own accord," he said. He encouraged people

to get active at school board meetings and run for open positions.

There did not appear to be a presence from local police or law enforcement agencies for the event. Most participants largely stayed within the park throughout the rally with brief periods where people lined Main Street with posters and flags.

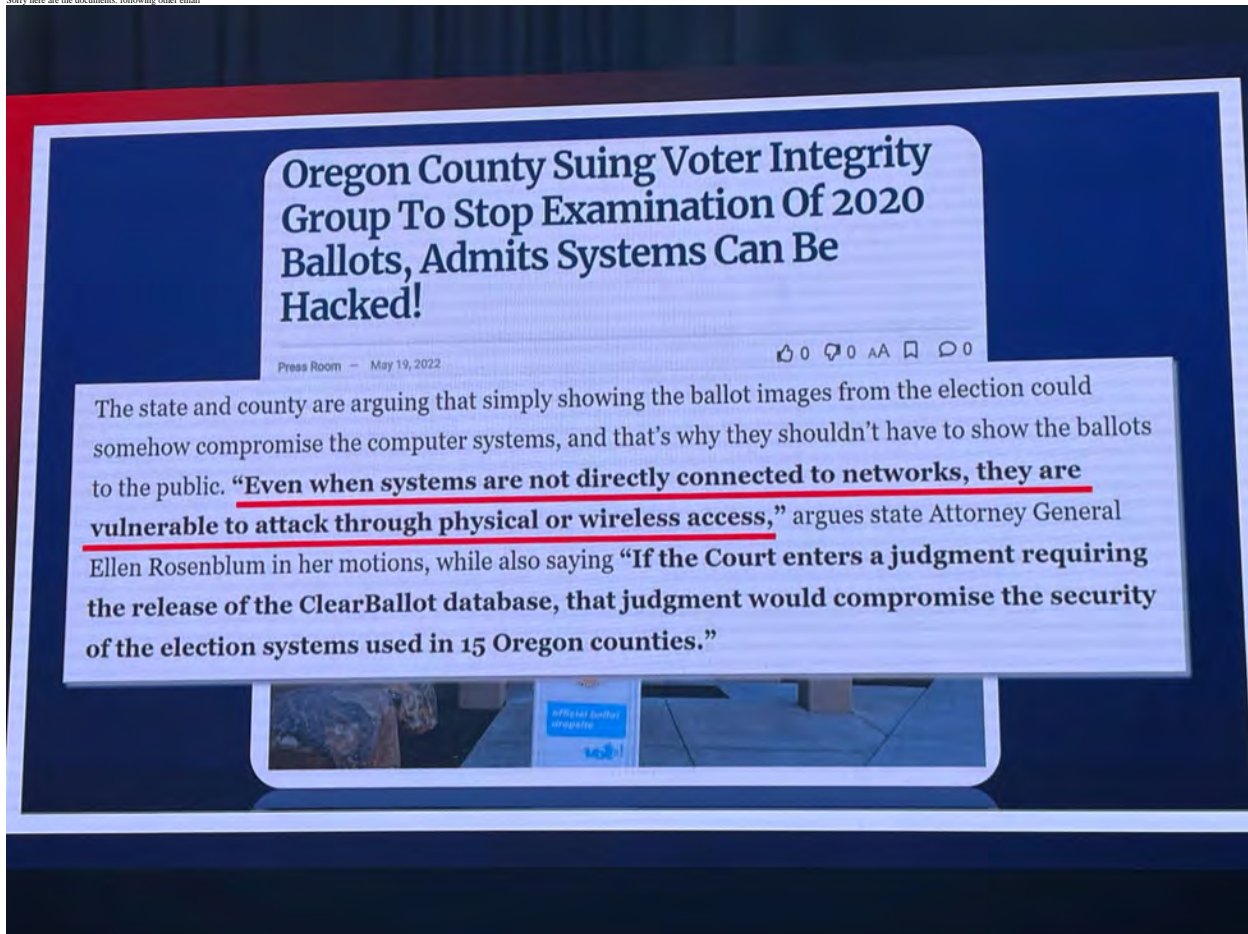

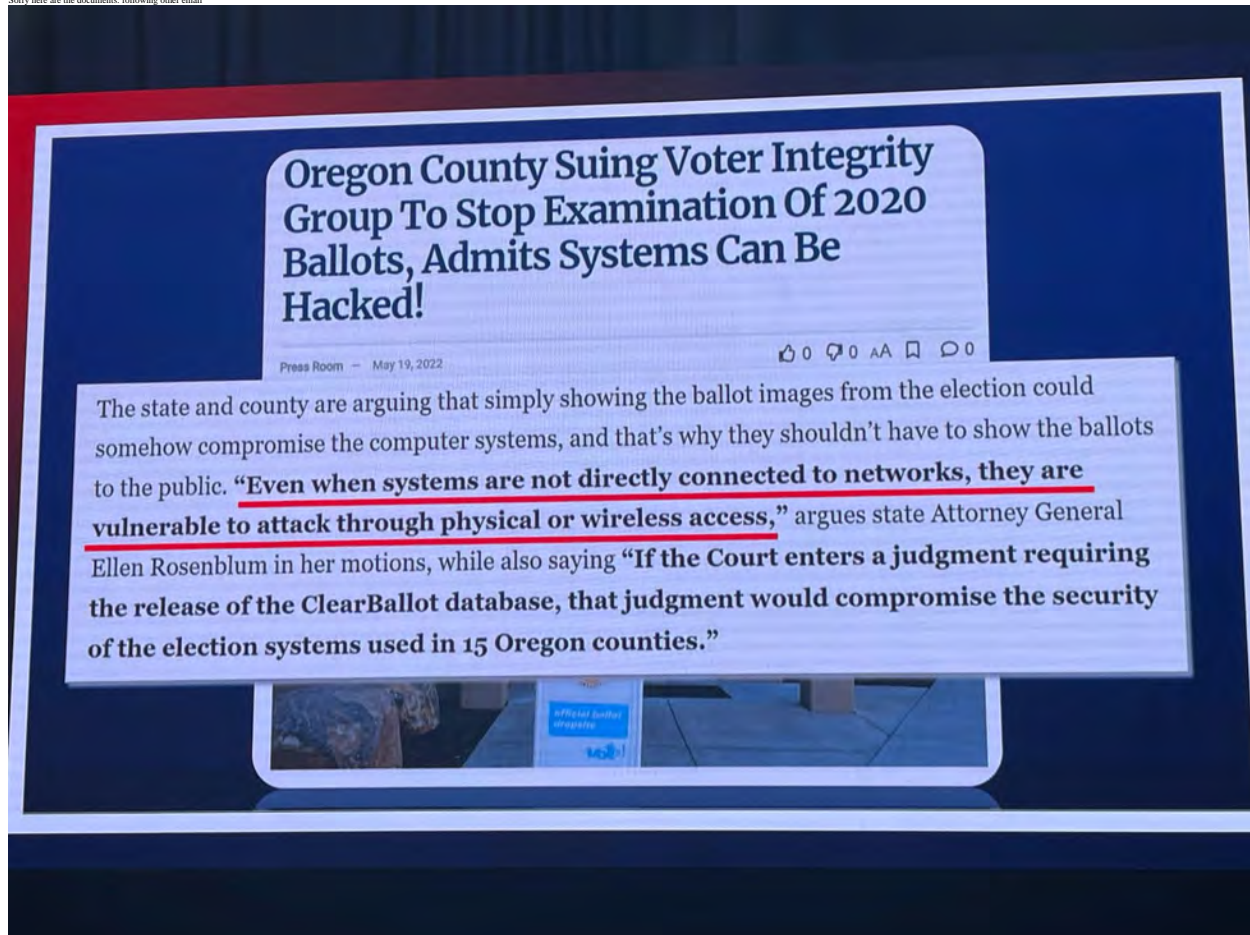
