Dear Marwah,

I am in receipt of a re-submitted request dated March 17th for records from the Waukesha County Sheriff's Department pursuant to Wisconsin Public Records Law. I am a designated Records Custodian for the Waukesha County Sheriff's Department, and I am hereby responding to your request. Such requests for records are governed by Section 19.35 of the Wisconsin Statutes, as well as other applicable and controlling law. Your re-submitted request narrowed the search asking to provide all responsive records from September 1, 2021, through November 30, 2022.

In your re-submitted request, you seek:

“All email communications (including emails, complete email chains, email attachments, calendar invitations, and calendar invitation attachments), text messages (including complete text message threads or conversations), and messages on messaging platforms (such as Slack, GChat, Google Hangouts, Lync, Skype, or WhatsApp) between (a) Eric Severson or anyone acting as Sheriff Severson's deputy or agent, or communicating on Sheriff Severson's behalf, and (b) any of the external individuals or entities listed below (including, but not limited to, at the listed email addresses or domains).

Michael Luell, or anyone communicating on behalf of the Racine County Sheriff’s Department. **21 pages of responsive records were located.** I have determined that some of the information is not subject to release and have redacted that information that is not subject to disclosure, as the names and email addresses of Federal Agents have been redacted. These individuals were not the subject of your request. I must consider applicable federal law. Section 19.36(1), Wisconsin Statutes places limitations upon access and withholding of public records by instructing that any record which is specifically exempted from disclosure by state or federal law or otherwise exempted from disclosure by other laws may be exempt under Wisconsin’s Public Records law. The public policies expressed in the exceptions to the United States Freedom of Information Act (FOIA) “provide a framework that records custodians can use to determine whether the presumption of openness in law enforcement records is overcome by another public policy.” *Linzmeier v. Forcey*, 2002 WI 84, ¶ 33, 646 N.W.2d 811. The FOIA exempts law enforcement records from


public disclosure under a variety of circumstances. See generally 5 U.S.C. § 552. I have redacted portions of records that reveal names and contact information of federal employees. Pursuant to the FOIA, 5 U.S.C. §552(b)(7)(C), as disclosure of which would constitute a clearly unwarranted invasion of personal privacy; and information which could reasonably be expected to constitute an unwarranted invasion of personal privacy. The federal government often redacts the names, phone numbers and e-mail addresses of Federal Agents and staff due to their job duties and to protect them against unwanted contact and harassment from members of the public and I have done the same.

19. Tim Griffin, or anyone communicating from an email address ending in thomasmoresociety.org. **No responsive records were located.**

With regard to costs, Sec. 19.35(3)(c), Wis. Stats. authorizes a records custodian to impose a fee for the actual, necessary and direct cost of locating records, when such cost exceeds \$50. The search for responsive records took 6 total hours, and the lowest paid employee able to conduct that search is compensated at \$29.17 per hour. As such, the total cost of locating responsive records specific to this request is \$175.02. Sec. 19.35(3)(a), Wis. Stats. authorizes a records custodian to impose a fee upon the requester to reproduce records which may not exceed the actual, necessary and direct cost of reproduction of the record. The response to your public records request has produced a total of 33 pages at the rate of 25 cents per page, resulting in a copy charge of \$8.25. The total cost of this record request is **\$183.27**. Because this amount exceeds \$5, I am authorized to require prepayment before providing the copies pursuant to Sec. 19.35(3)(f), Wis. Stats. Please arrange payment, made payable to the Waukesha County Sheriff's Department, and submit it to the Waukesha County Sheriff's Department at the address on this letter. Upon payment, the responsive records will be released.

Finally, please be advised that decisions of records custodians with respect to Public Records requests are subject to review under Sec. 19.37(1), Wis. Stats. in an action for mandamus, or by application to the District Attorney or Attorney General.

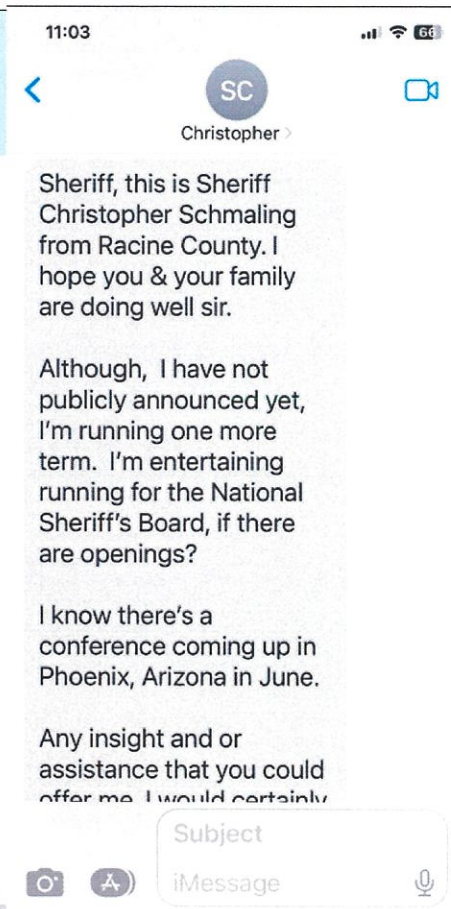
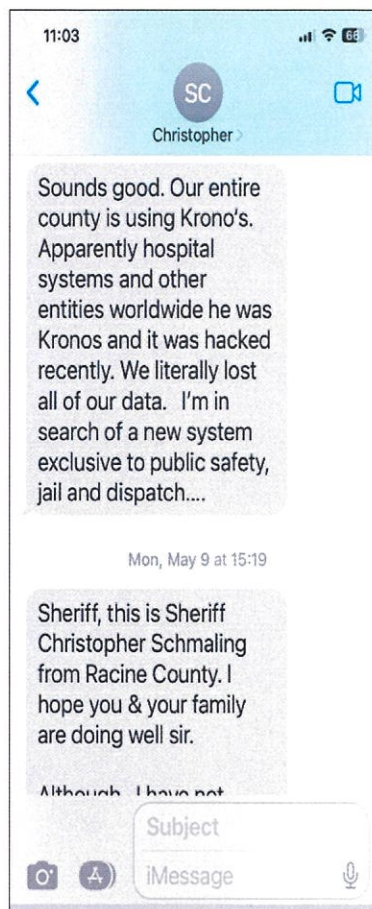
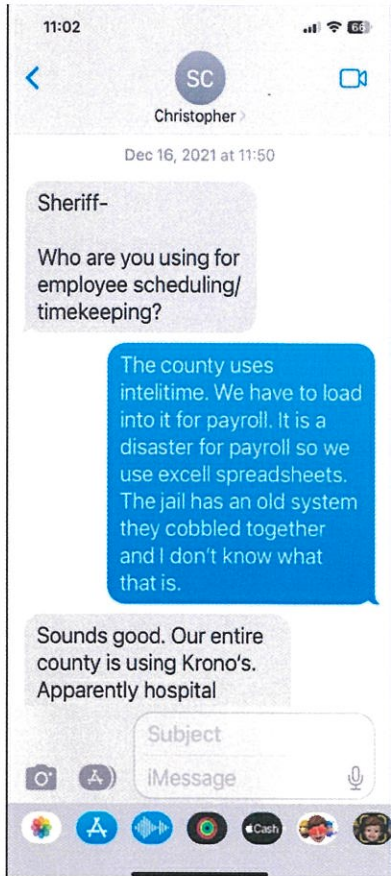

Re: Criminal complaint against Meagan Wolfe and Robert Kehoe

I allege Meagan Wolfe and Robert Kehoe committed the crime of felony misconduct in public office. Wis Stat 946.12. Wolfe is the Administrator for the Wisconsin Election Commission. Kehoe is the IT person and the Deputy Director. Each is a public employee of that agency. Together they created a deceitful scam upon the six Board of Commissioners of the Wisconsin Election Commission ("WEC"), upon your municipal clerks, your county clerk, and the public at large.

Both had a known duty to follow state statute whereby any voting system, machine, device or related equipment must be tested by the staff and then certified by a 4 to 2 or better vote by the six board Commissioners. Wis Stat 5.91. Wolfe and Kehoe tricked the six Commissioners to vote for approval of the ES&S 6.0.5.0 and Dominion 5.5-CS systems which have modem capability. They lied by omission to the Commission however as modems have never been certified. Wolfe wrote in her June 2nd, 2021 staff memo to the Commission

"The modeming components of Democracy Suite 5.5-CS do not meet federal certification standards. However, the underlying voting system is federally certified." Page2

The underlying voting system was federally certified – without any modem. Modems cannot be certified as they are a two-way street of communication. The election results on election night go out of the modem, through the internet I have learned, ending up in the County Clerk's election management system (EMS). However, it is possible for malicious code to be transmitted back to the tabulators at that time also. This is exactly why the federal government (the EAC) never certified the modems. And of course, for the modem to transmit data they have to transmit to something. That is the "Listener" computer server sitting at the County office. Exposing another pathway for a hacker to enter the election system. When I found the internet IP address on a tabulator tape I step-traced it back. It showed 30 connections, meaning hitting 30 different computer server locations before it stopped. It ended up in Finland. That does not mean election data ended up in Finland, but it does mean it could have. The possibility exists and this is why modems have never been certified.

To my knowledge, each of your municipal clerks uses a wireless modem to transmit the election results on election nights to your county clerk.

As stated, the modems used on Dominion and ES&S Tabulators have never been certified. They have not been certified by the Feds (EAC). Meagan Wolfe wrote in her October 10, 2019 report to the WEC Board about the ES&S tabulators *"The Modeming component of EVS 6.0.5.0 lacks federal Certification but has undergone successful*

functional testing on the state level. The underlying voting system (EVS 6.0.4.0) is federally certified.” This means the base system was certified but not the modems. “Functional” testing just means checking to see if the modems worked. Not if they were certified. You can’t connect an uncertified modem into a tabulator and claim the tabulator is still certified. As soon as the modem is plugged into the tabulator, or turned on if internal, the entire tabulator is uncertifiable. This is how Meagan Wolfe hoodwinked the six Commissioners, your clerks and us the public, she wrote “*EVS 6.0.4.0 is a federally - tested and certified paper-based, digital scan voting system powered by the ElectionWare software platform. It consists of six major components: an election management system (EMS) server; an EMS client (desktop and/or laptop computer); the ExpressVote, an Americans with Disabilities Act compliant vote capture device for a polling place; the DS200, a polling place scanner and tabulator; the DS450, a mid-range scanner and tabulator for a central count location; and the DS850, a high-speed scanner and tabulator for a central count location.*” Do you see what is missing? No mention of modems at all. Where she plants in your mind the 4.0 ES&S is federally certified. But then here is Wolfe’s first deceit: “*EVS 6.0.5.0 is a federally-tested modification to the EVS 6.0.4.0 voting system.*” She switches to the phrase “federally-tested”, but not certified by the Feds. It can’t be certified if it has a modem connected to it in any manner. Wolfe continues “*The modeming component of EVS 6.0.5.0 lacks federal certification but has undergone successful functional testing on the state level.*” Once again she deceives us by reassuring us all ‘it is ok, it has undergone functional testing.’ And it was “successful”. Yes, well when I start my car that it is a successful, functional testing of my starter - that doesn’t mean it is certified. But don’t worry, Wolfe then writes “*The underlying voting system (EVS 6.0.4.0) is federally certified.*” Yes, it is – BUT WITHOUT A MODEM. Meagan Wolfe lied to the Board of Commissioners by omitting on purpose the modems have never been certified by anyone. Kehoe helped her write these staff memos to fool the Commissioners. The modems would never pass federal Voluntary Voting System Guidelines (VVSG). These are the standards WEC uses when they want to certify something. Wolfe and Kehoe lied to your clerks, to us all.

Wolfe repeats her trickery with the Dominion voting system in her June 2nd, 2021 Staff Memo to the WEC Board, writing:

“Democracy Suite 5.5-CS is a federally tested modification to the EAC certified Democracy Suite 5.5-C voting system. Democracy Suite 5.5-CS provides support for modeming of unofficial election results from an ImageCast Evolution or ImageCast Precinct 2 tabulator to a Secure File Transfer Protocol (SFTP) server through encrypted wireless telecommunications networks after the polls close on Election Day. The modeming components of Democracy Suite 5.5-CS do not meet federal certification standards. However, the underlying voting system is federally certified.”

P.2 June 2nd 2021 Staff memo to the WEC Board. See again, it is “federally tested” but NOT certified. “*Modeming components...do not meet federal certification standards,*” but don’t worry “*...the underlying voting system is federally certified.*” This 61-page Staff

Memo has a list of all items seeking certification by the WEC Board. The list is in Appendix A. Modems are not on the list. Thus, the WEC Board never voted to approve the use of modems in our elections. Wolfe and Kehoe knowingly and intentionally omitted modems from the Appendix. Modems are not permitted by state law. Wis Stat 5.91(10). Both memos and resulting “approvals” were transmitted by Wolfe and Kehoe to the clerks in your county.

If a modem is used on any tabulator, the tabulator becomes uncertified. If a modem transmits election results to the county then the entire EMS at the county level becomes uncertified. You can't plug in an un-certified modem to a certified tabulator as it immediately makes the tabulator uncertified. As soon as the uncertified modem connects to the internet, or VPN or other communications carrier, when it reaches the EMS at the county level it immediately makes that EMS uncertified. It is against the law to use any voting device, machine or system in our elections if not certified.

As more evidence weeks ago I submitted a public records request to WEC asking for the record showing the modems were certified by a vote by the WEC Board. WEC has never produced any records. Modems have never been certified by WEC. Meagan Wolfe and Robert Kehoe lied to the WEC Board, lied to all of us. Their memos are on the WEC website. <https://elections.wi.gov/>

The lie to your municipal and county clerks by Wolfe and Kehoe was them informing the clerks ‘the WEC Board has approved these voting systems’, yet omitted the modems were never even submitted – let alone voted upon – to that same Board for a vote. As a result, your clerks believe modems are certified when they are not. They believe the tabulators and EMS are certified. But neither is the second the modems are connected/used, which already happened of course during the August 9, 2022 primary.

Ask your clerks if they knew Wolfe and Kehoe omitted the modems from the documents submitted to the WEC Board for a vote to approve their voting systems. Ask them if they knew the WEC Board never voted to approve the modems. Ask them if they knew as soon as they connect an uncertified device – the modems – to the tabulators the entire system immediately becomes uncertified.

I ask for an investigation of Wolfe and Kehoe. For them to be charged where appropriate.
