JONES, a black female, born October 19, 1998**, hereinafter referred to as the defendant, and bring the said defendant before a Magistrate in and for Tarrant County, Texas, instanter, then and there to answer the State of Texas for an offense against the laws of said State, to-wit: **Terroristic Threat-Impair Government Service**, a Felony, of which offense she, the said defendant, is accused by the written Affidavit, under oath of Detective Daisey Blanco # 1752, a police officer with the Arlington, Texas, Police Department, filed before me anterior to the issuance of this Warrant.

Said **Shalaria E. Jones, a black female, born October 19, 1998** is hereby committed to the appropriate jail for custody.

ARREST WARRANT AFFIDAVIT

Before me, the undersigned authority on this day personally appeared Detective Daisey Blanco #1752, a police officer with the Arlington, Texas, Police Department, who after being duly sworn on oath deposes and says THAT SHE HAS GOOD REASON TO BELIEVE AND DOES BELIEVE THAT:

On or about November 17, 2015, in Arlington, Tarrant County, Texas, **Shalaria E. Jones, a black female, born October 19, 1998** did then and there commit the offense of **Terroristic Threat-Impair Government Service**, a Felony, in that she did THEN AND THERE INTENTIONALLY THREATEN TO COMMIT AN OFFENSE INVOLVING VIOLENCE TO THE PUBLIC OR A SUBSTANTIAL GROUP OF THE PUBLIC, TO WIT: ARLINGTON INDEPENDENT SCHOOL DISTRICT-BOWIE HIGH SCHOOL, NAMELY OF MASS MURDER, WITH INTENT TO PLACE FACULTY AND STUDENTS OF BOWIE HIGH SCHOOL IN FEAR OF IMMINENT SERIOUS BODILY INJURY.

MY BELIEF AS AFORESAID IS BASED UPON THE FOLLOWING FACTS AND CIRCUMSTANCES:

On or about November 17, 2015, **Shalaria E. Jones, a black female, born October 19, 1998** intentionally threaten to commit an offense involving violence to Bowie High School Students and placing faculty and students of Bowie High School in fear of imminent serious bodily injury. Said offense was reported by Officer R. Morrison #1746 to the Arlington Police Department as offense report #150061448 on November 17, 2015.

On Tuesday, November 17, 2015, School Resource, Officer Morrison #1746 and Officer Clint Adam #1923 were made aware of a threat at Sam Houston High School. An additional threat was posted via a Twitter account identified as "whitebitch@whitebitchhoe". The threat was directed towards students at Bowie High School, located at 2101 Highbank Dr., Arlington, Tarrant County, Texas. The threat from the Twitter account was tweeted at 0833hrs on November 17, 2015 and it read "@12 be readie for bowie to hav a schoo shootin".

This information was relayed to the Arlington Police Department Tactical Intelligence Unit Sgt. Rogers #1396 who contacted Twitter and completed an Emergency Disclosure request for the whitebitch@whitebitchhoe account. This Twitter account returned to IP address 172.56.184 with a T-Mobile phone #469-535-0099. Sgt. Rogers conducted a Clear search and the phone number returned to Shalaria Jones. Shalaria E. Jones was determined to be a Bowie High School student and was positively identified as **Shalaria E. Jones, a black female born, October 19, 1998**.

School resource officers made contact with Shalaria E. Jones at her residence. Shalaria E. Jones withdrew from Bowie High School due to the terroristic threat. Shalaria E. Jones stated she was aware of the terroristic threat because she had received the threat over her Twitter account. Shalaria E. Jones stated she is not allowed to utilize her phone in her first period class with Mrs. Dowell. Her first period class is from 0735hrs till

0905hrs.. Although she is not allowed to utilize her phone in first period class, Shalaria E. Jones admitted to receiving the terroristic threat tweet via Twitter and notified Mrs. Dowell. Shalaria E. Jones stated that she was the only person to be in possession of her phone during her first period class until she allowed her friend [redacted] to utilize her phone to notify her mother of the terroristic threat. She allowed [redacted] to utilize her phone during second period class. Second period class starts at 0910hrs which is well after the terroristic threat tweet posted at 0833hrs.

Shalaria E. Jones provided written consent for AFFIANT to search her Samsung Galaxy S4 Android 4.3 Version mobile phone, Model #SGH-M919N, and Baseband Version M919NUVUEMK5. AFFIANT advised Shalaria E. Jones that her phone #469-535-0099 was associated to the Twitter account that sent the terroristic threat tweet, whitebitch@whitebitchhoe along with an IP address that was associated to a T-Mobile phone. Although Shalaria E. Jones admits to knowing how to create a Twitter account she denies creating the account or tweeting threats on her phone because she knows this could cause her to get into trouble. A search on Shalaria E. Jones personal Twitter account thatgalshaay revealed that Shalaria E. Jones had not had any activity on the account since July 30, 2015, until November 17, 2015. Shalaria E. Jones retweeted the terroristic threat post on her personal account, however a follow up check on November 18, 2015 revealed that the retweet and anything related to the terroristic threat had been deleted and removed.

AFFIANT asked Shalaria E. Jones if she conducted any type of google searched involving guns, knives, bombs, or grenades on her phone. She denied conducting any type of search. As AFFIANT searched Shalaria E. Jones phone AFFIANT observed that there were two separate searches for "picture of gun". Due to technical difficulties and difficulties in maneuvering through the phone it was decided that the phone would remain in our possession for further investigation and Shalaria E. Jones agreed.

AFFIANT met with [redacted]. Shalaria E. Jones allowed [redacted] to utilize her phone in second period to notify her mother reference the terroristic threat. [redacted] advised AFFIANT that Shalaria stated to her "I have to show you something". This is when Shalaria E. Jones showed [redacted] screen shot of the terroristic threat tweet. [redacted] confirmed that Shalaria E. Jones allowed her to utilize her phone during second period to contact her mother.

After the terroristic threat post on Twitter the school began receiving numerous tweets from students and parents who were concerned for their safety. Numerous parents withdrew their students from school due to the tweet and caused a chaotic scene when approximately 200-300 students left school due fearing for their safety. Approximately eight calls were received by calltake from concerned Bowie High School student parents. Approximately twelve officers were assigned to work and or provide protection for Bowie High School students.

On November 18, 2015, your AFFIANT obtained Search Warrant 08-15-040SW signed by Judge Vera Verhoeven for Shalaria E. Jones Samsung Galaxy S4 Android mobile phone. The phone was released to Economic Crimes Detective V. Phan #2228 for analysis. The analysis determined that at 08:24:04 a google search for "picture of gun" was searched through google utilizing this phone. At 08:24:34hrs the same handgun image that was utilized in the twitter terroristic threat was cash filed on the phone indicating that the photograph was selected. Twitter activity was observed on the phone between 08:25hrs and 08:33hrs. At 08:28hrs a twitter account was created and at 08:33hrs a post was uploaded onto Twitter. This timing is the same time that the Twitter terroristic threat was made by whitebitchhoe which had the image of the gun. This gun image is the exact gun image that was cash filed onto Shalaria E. Jones phone at 08:24:34hrs.

Shalaria E. Jones advised AFFIANT that she was the only person in possession of her phone during her first period class from 0735hrs to 0905hrs. She places herself as the only person who could have searched the picture of gun and posted onto the Twitter account.
