This is a request under The Freedom of Information Act by The War Horse, a nonprofit newsroom covering military and veterans' issues. (EIN: 82-1669255)

Pursuant to the federal Freedom of Information Act, 5 U.S.C. § 552, I am seeking court martial records from the Coast Guard Court of Criminal Appeals. Specifically, I'm looking for court martial records that include the following search terms: "sodomy" and/or "conduct unbecoming" and/or "indecent act." To narrow the number of records, I'm only seeking cases from 1980, 1985, 1990, 1995 and 2000.

I'd like to receive above records in five separate installments.

As a representative of The War Horse, a full-time newsroom dedicated to covering military and veterans' issues, I ask that any and all fees and other charges be waived as this request is in the public interest. This request is not intended for commercial use.

If my request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions of the act. I prefer electronic files and correspondence when available.
