Thank you for the update.

All responsive documents must be produced by <u>May 31, 2024</u>. I originally sent the FOIA request on August 24, 2023, and MSHA responded to the FOIA Request on September 22, 2023. Therein, MSHA stated that, due to the unusual circumstances of the FOIA Request, it estimated it would take 60 working days from September 22, 2023 to process the request. I received no responsive within the 60 working-day period and I did not hear from MSHA regarding the need for any additional time.

I followed up on January 2, 2024. MSHA responded the next day, and said it "anticipate[d] finalizing the response and completing the clearance process" for the FOIA Request by February 29, 2024.

That date came and went with no response from MSHA. I followed up again on March 13, 2024, inquiring about the timing of MSHA's response. MSHA again followed up the next day, requesting a time to speak about the request. On a call regarding the FOIA Request, we discussed the requests and I offered to agree to rolling production of records in order to speed up the process. I followed up the next week, asking for an update on the timing of production.

MSHA did not respond. I followed up again on March 28, 2024. MSHA responded and said it was "checking on the status of [the] request" and would "get back with [me] by tomorrow with an anticipated completion date." MSHA did not follow up the next day due to an "unexpected absence," but promised to provide at update as soon as possible.

I never heard back from MSHA, so I followed up again on April 16, 2024. Thereafter, MSHA responded with the below email.

At this point, absent a complete production on May 31, 2024, MSHA will be in clear violation of the statutory and regulatory requirements regarding the FOIA Request. MSHA's failure to respond to the request, after all reasonable efforts to accommodate the agency with additional time, are a denial of the rights created by FOIA.

MSHA's failure to respond within the statutory time limitations means that the administrative remedies have been constructively exhausted, *see* 5 U.S.C. § 552(a)(6)(C)(i), and, assuming MSHA fails to respond in full to the request by the date above, I will seek to enforce my FOIA rights in federal court.
