Detailed Record Description: We seek comprehensive ESI and records, including but not limited to emails, memos, reports, logs, investigation files, access records, and communications with media entities, that document or reference: • The unauthorized disclosure or leak of confidential investigation records to CNN or any third parties. • Any unauthorized release of records related to CAPT Glenn Sulmasy or the investigations and allegations against him from 2010 forward. • Any administrative or criminal investigations that were completed regarding the leak of these confidential records. • Any adverse administrative or military justice actions that were taken against any individual for acts reasonably related to this leak of these confidential records. Time Frame of Interest: The request covers records from January 1, 2010, to the current date, to encompass all relevant information and incidents related to the unauthorized release of information. Specific Incidents and Allegations: The request is in response to a CNN report dated September 21, 2023

This specifically includes, but is not limited to, records that pertain to who, what, where, when, or how, the confidential records were leaked or how CNN received copies of the investigation, correspondence and deliberations on the investigation, and evidence, such as the published texts present in the report. Public Interest and Fee Waiver: There is a significant public interest in understanding how sensitive government information, especially concerning legal and disciplinary matters, is managed and protected. We assert that releasing these records will greatly contribute to public understanding of these issues and request a waiver of all associated FOIA processing fees. Should you foresee any delays or challenges in fulfilling this request, please provide an estimated completion date. If parts of this request are denied, please cite the specific exemptions under the FOIA that justify this decision and inform us of the available appeal procedures.
