Dear Roman Jankowski:

This is to acknowledge receipt of your Freedom of Information Act (FOIA) requests dated and received in this Office on August 13, 2024, seeking communications sent by various Department officials containing various terms since January 20, 2021.

On the same business day, you submitted to this Office sixty-four separate, but interrelated and overlapping FOIA request letters seeking the same records from various officials within the Office of the Attorney General, Office of the Deputy Attorney General, Office of the Associate Attorney General, Office of Legislative Affairs, Office of Legal Policy, and Office of Public Affairs. For purposes of clarity, these requests have been further detailed in the attached spreadsheet.

As a matter of administrative efficiency and in an effort to facilitate our records searches and the processing and consultation of potentially responsive records, and ultimately to more efficiently respond to your requests, we are aggregating your requests under the tracking number FOIA-2024-03041. We will conduct a comprehensive records search designed to locate records that may be responsive to any or all of your requests. This administrative action will eliminate any redundancies amongst our records searches while also removing the need to process and conduct consultations on duplicative records that would have been responsive to one or more of your individual requests. The remaining tracking numbers will be closed administratively.

The records you seek require a search in and/or consultation with another Office, and so your request falls within "unusual circumstances." See 5 U.S.C. 552 § (a)(6)(B)(i)-(iii) (2018). Because of these unusual circumstances, we need to extend the time limit to respond to your request beyond the ten additional days provided by the statute. For your information, we use multiple tracks to process requests, but within those tracks we work in an agile manner, and the time needed to complete our work on your request will necessarily depend on a variety of factors, including the complexity of our records search, the volume and complexity of any material located, and the order of receipt of your request. At this time, we have assigned your request to the complex track. In an effort to speed up our process, you may wish to narrow the scope of your request to limit the number of potentially responsive records so that it can be

placed in a different processing track. You can also agree to an alternative time frame for processing, should records be located, or you may wish to await the completion of our records search to discuss either of these options. Any decision with regard to the application of fees will be made only after we determine whether fees will be implicated for this request.

We regret the necessity of this delay, but we assure you that your request will be processed as soon as possible.
