In addition, it has come to my attention that a member of the State Elections Board, Ed Lindsey, is a paid lobbyist for DeKalb County. My question to the SEB, the Secretary of State and the Attorney General's Office is whether Mr. Lindsey made any inquiries or engaged in any discussions with anyone in either of your offices regarding this matter. Mr. Lindsey, would you care to comment on that question? Did you take any steps to block consideration of these complaints filed against your client?

It appears to me that there is a behind-the-scenes effort to thwart the development and disclosure of all information and facts regarding this matter.

Please consider this an amendment or supplement to the Complaint filed on February 5, 2023, updated on April 4, 2023 – and asking for investigation into the following additional matters:

1. What actions were taken by either the SEB or the SOS to investigate DeKalb County's solicitation and acceptance of private funds from the US Alliance for Election Excellence? Please provide a complete report of the investigation(s) conducted in response to my complaint.

- 2. What actions have been taken to ensure that DeKalb County did not accept additional funds from USAEE or from any other private party in 2023 or 2024? Has DeKalb County accepted additional private funds from any private party this year?
- 3. Did SEB Member Ed Lindsey engage in any conversations or discussions with any person at or on behalf of DeKalb County regarding the USAEE grant at any time in 2022, 2023, or 2024?
- 4. Did SEB member Ed Lindsey engage in any conversations or discussions with any person at the SEB or the Secretary of State's office regarding the funds solicited or received by DeKalb County from the USAEE?

The utter disregard of these complaints by the SEB and the SOS is disgraceful. Both of you appear to have clearly colluded to ignore illegal behavior by DeKalb County, thereby making the matter of the illegal funding even worse. Now, it appears there is a coverup by the SEB and the SOS and a complete failure to make any effort to get to the truth.

And that disgraceful behavior is compounded by the fact that a member of the SEB is a paid lobbyist for DeKalb County, which further clouds the trust that citizens can have in the very body that is established by law to oversee the election offices and administration in the State of Georgia, and to ensure that every election office is held to the highest standard of ethical conduct.

As we go into this important election year, it is unforgivable that neither the SEB nor the Secretary of State seem to be at all concerned about whether DeKalb County is going to be required to act in accordance with the law.

I would appreciate a report from both of your offices at the earliest possible date responding to my questions and this additional complaint to supplement the complaints and materials previously provided last year.

It is the county's responsibility to maintain their voter rolls. It is proper and appropriate to contact the counties directly with voter list maintenance tasks. My project assignment as a board member is voter list maintenance. This is a simple preliminary study of data accuracy, errors, and root cause and I am acting on behalf of the board as instructed by Chairman Duffey. Any objection should have been made a year ago. I will continue to act as instructed until we have a meeting and vote otherwise.

The SOS office has communicated that their GARViS program is not "catching" these duplicates, which further validates the need for this study.

Finding many exact match duplicates of the Secretary of State's own list without the added PII available to the SOS does not meet the level of "robust." Actually, the SOS should identify many more duplicate registrations than any person reviewing the abridged public lists provided by the SOS.

I hope to get 30-50 counties review and feedback so I can draw some conclusions and make recommendations to the SEB, SOS, and General Assembly.

I am in receipt of your email of September 20, 2023 labelled HIGH PRIORITY - SEB 2023-0025. I take the opportunity to write to you so that you will know that the Board has received your email and to provide you with information and details about the State Election Board about which you might not be aware.

1. "This complaint needs to be addressed at your next meeting on October 3, 2023, we should not have to wait until the following December 2023 meeting."

The Board published the Agenda for the October 3, 2022 meeting on September 18, 2023. Prior to the publication of the Agenda many, many hours were spent in preparing matters for presentation to the Board. All of the matters on the Agenda are just as important to those Complainants and Respondents. Since I have been on the Board, I do not recall a single instance where the Board added an item to its regular meeting Agenda after that Agenda was published. The reason for this is transparent.

The Members of the Board are all unpaid volunteers donating willingly and generously of their time for the good of the State and its Citizens driven by a deep and abiding aspiration for free, fair and transparent elections (and for all that hard work are subjected to a daily barrage of insults, invective, threats of suit and even personal threats against them and their families including their children). Between now and the October 3rd meeting, the Board Members will study and review a giant binder of just under forty cases (many with multiple constituent subparts) every one of which is earlier than 2023-0025 (the latest case on the October Agenda is 2023-001). This is in addition to three petitions for rule making that will be considered by the Board at the October 3rd meeting which total over three hundred (300) pages. Many of the Members of the Board are lawyers and they will be conducting hours upon hours of legal research and analysis with regard to the petitions for rule making. Even the Member of the Board who is not a lawyer by training spends countless hours in deep study to diligently understand all aspects of the cases and petitions coming before the Board. Since the petitions for rule making arise out of law suits, the Members of the Board will be pouring over many hours worth of transcripts and pleadings as well (a few of which you attach to your email but as to which there a many, many more).

In addition to all that, the Board is just coming off of three solid days of budget research and writing.

2. "Reviewing this SEB Complaint, **it is hard to understand why this** detailed accounting of 41,690 unverifiable votes that were certified for Fulton County in the 2020 General Election **has been ignored**." (emphasis supplied)

I personally have spent easily over one hundred hours studying Mr. Rossi's multiple submissions as well as the document you attached to your email (as well as supporting documentation not attached by you but attached to emails from other supporters of Messrs. Rossi and Moncla that seem to arrive daily). I'm sure the other Board Members have studied the matter as well. The Governor's Staff diligently studied it. The Secretary of State's staff has studied it and is in the process of studying it on a daily basis. The Secretary of State's office has maybe ten to twelve Boards that their investigators have to cover (I'm sorry that I do not know the exact number. It may be less or it may be a great many more). I suspect that their investigations for the State Election Board take up well over half of their total time spent.. There is no set of facts or circumstances where 2023-0025 could reasonably or fairly be described as "ignored."

This Board attends to its duties with diligence and great care giving full and due consideration to all the matters that come before it. Any assertion to the contrary by anyone, anywhere is made by someone who does not know the Members of this Board and how seriously they take their tasks.

Thank you for taking the time to contact the Board with your thoughts and concerns. On a personal note, I remember Jenny Beth Martin from my days in the Coverdell Leadership Institute (now known as Republican Leadership for Georgia). Jenny Beth and I were in the last CLI class before Senator Coverdell tragically passed away. If you see Jenny Beth, please extend to her my greetings.

Thank you for your thorough, thoughtful and informative reply. First I want to say that I am sincerely sorry that the SEB Board Members are being subjected to insults and multiple types of threats. Unfortunately, everyone volunteering and working hard for fair and transparent elections has received insults, threats and also, unresponsiveness and delays from a multitude of county boards, elections departments, etc. and this is very troubling, so we understand firsthand how emotional and disruptive this can be. Secondly, I want to thank you and all the Board Members for serving on the SEB, it cannot be an easy appointment.

1. The first thing concerning this very serious SEB 2023-025 complaint was submitted in July 2022 and the complaint was not assigned with a case number until March or April of this year. It took 9+ months to log this complaint. That does not feel very transparent.

That would make this complaint much older than the latest case being heard at the October 3rd meeting, which looks to be the first complaint filed in 2023, with the number 2023-001. And not knowing the processes and procedures, I am not sure how the cases are logged and an investigation starts or what person or department caused the 2023-025 complaint to be so terribly delayed by 9+ months.

2. During the last SEB Meeting, in August 2023, there was not an agenda item for 2020-181, and this being unexpected and very limited board discussion, the complaint meaning was not clear to the public, nor do I remember any investigation details given, to the public or to the Board Members who did not even have a copy of or knowledge of it but was voted favorably to a Consent Agreement with Fulton County. And you are correct, putting an Agenda item without prior notice to the public or even the Board Members, does show a tremendous lack of transparency, as it did with 2020-181. Agenda link below.

I was not aware of the Secretary of State Investigators being assigned to 10 to 12 and possibly more boards, thank you for the explanation.

This clearly sheds a new light on the SoS Investigators being spread too thin. Hopefully our legislators have provided funding for the SEB to have independent Election Investigators who are focused solely on election complaints. All citizens of the state deserve fair, transparent elections and for serious complaints in these elections be investigated in a timely manner.

I do appreciate all of the Board Members volunteer work on the SEB and the hours put in to fully understand these election complaints and I hope that you understand that my email was not intended to be threatening in any manner. The email was sent in frustration that this very serious complaint of 41k+ votes from unverifiable ballots in the 2020 General Election that were sent in July 2022 and not assigned a case number for 9+ months, but was submitted 15 months ago and has not been put on an agenda.

Again, I appreciate all of your hard work and all that goes into being a State Elections Board Member. It cannot be an easy appointment.

Over a year ago, I submitted multiple important complaints (regarding incidents which I experienced firsthand) to the SOS. I was finally going to be given a chance to address two of my cases, SEB 2021-135 and SEB 2021-136, next week at the December 13th 2022 SEB Meeting. Unfortunately, at the last minute, the SEB has decided to bundle my complaints into a single SEB case, SEB #2022 -217.

I spoke with SOS Supervisor Gilbert Humes this morning and he informed me that the SOS now believes that these two cases, which Investigator Trent Anding had previously recommended to be dismissed by the SEB with a recommendation to the SEB to close the cases with **no violation**, HAVE MERIT. Furthermore, these two cases are being bundled into a new case: SEB 2022-217. I asked Gilbert if the epically slow walked SEB 2021-100 would also be included within SEB 2022-217 and he informed me that it would.

While I appreciate that the SOS now believes that all three of my complaints HAVE MERIT, I cannot help but feel that creating a new case is a procedural tactic to kick my complaints down the road and further delay the facts coming to light.

I simply request that I be given a chance to address my concerns during the December 13th 2022 SEB Meeting as Sara Koth assured me in both SEB Case Notification Letters:

"Your attendance is not mandatory, but should you attend, the SEB will provide you with an opportunity to address them about your case."

Judge Duffey, may I please be given a few minutes to address my concerns at the December 13th 2022 SEB Meeting?



Dear 34N22, Inc:

On August 1, 2023, the State Election Board considered the complaint listed above.

At the August 1, 2023, meeting, the State Election Board reviewed the facts developed in the investigation of this matter and voted to dismiss and issue this Letter of Instruction to you. The State Election Board did not find that a violation of O.C.G.A. § 21-2-570 occurred when your organization distributed gas and grocery vouchers while encouraging recipients to vote for a specific candidate for U.S. Senate.

O.C.G.A. § 21-2-570 states:

Any person who gives or receives, offers to give or receive, or participates in the giving or receiving of money or gifts for the purpose of registering as a voter, voting, or voting for a particular candidate in any primary or election shall be guilty of a felony.

When campaign activities are planned, it is important to instruct and educate all participants to clearly act within the framework of the law. Giving of money or gifts cannot be contingent on registering to vote, voting, or voting for a certain candidate.



With this Letter of Instruction, this case is now closed, and no further action will be taken.
