GREETINGS: WHEREAS, it has been represented unto us in our said District Court on the part of SCOTT, RAYMOND in a EMERGENCY PETITION FOR INJUNCTIVE RELIEF AND REQUEST FOR TEMPORARY RESTRAINING ORDER lately exhibited against you touching certain matters and things therein set forth; and, Whereas, the Honorable Lori Jupiter, a Judge of our said Court, upon due consideration thereof, has made and allowed an order in said cause, whereby you are required to show cause on the 4th day of November, 2024 at 9:00 o'clock AM why an injunction should not issue as prayed for in said EMERGENCY PETITION FOR INJUNCTIVE RELIEF AND REQUEST FOR TEMPORARY RESTRAINING ORDER; And Whereas, the said Judge has granted and allowed an order restraining you LOUISIANA STATE POLICE, LOUISIANA DEPARTMENT OFWILDLIFE AND FISHERIES, AND LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT immediately and forthwith and during the pendency of said motion for an injunction to the full extent and effect as prayed for in said EMERGENCY PETITION FOR INJUNCTIVE RELIEF AND REQUEST FOR TEMPORARY RESTRAINING ORDER.

Now, therefore, in consideration of the premises and of the allegations in said EMERGENCY PETITION FOR INJUNCTIVE RELIEF AND REQUEST FOR TEMPORARY RESTRAINING ORDER contained, you, the said LOUISIANA STATE POLICE, LOUISIANA DEPARTMENT OFWILDLIFE AND FISHERIES, AND LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, your agents, attorneys, and servants and each of you are hereby commanded and strictly enjoined under the penalty of law, that you and each of you absolutely refrain and desist from DEFENDANTS LOUISIANA STATE POLICE, LOUISIANA DEPARTMENT OF WILDLIFE AND FISHERIES, AND LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT SHALL:

A. NOT DESTROY OR DISPOSE OF THE PROPERTY OF UNHOUSED PEOPLE WITHOUT JUDICIAL PROCESS;

B. PROVIDE THE NOTICE SET OUT IN THE MUNICIPAL ORDINANCE (ART. XII, SEC. 82-696); AND

C. NOTIFY PEOPLE IN THE "STATE SANCTIONED CAMP" THAT THEY ARE FREE TO LEAVE And that you the said LOUISIANA STATE POLICE, LOUISIANA DEPARTMENT OF WILDLIFE AND FISHERIES, AND LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT your agents, attorneys, and servants and each of you remain so inhibited and restrained until the further order of our said Court in the premises.
