23 COUNT I:

24 That in the Third Judicial District, State of Alaska, on or about July 18, 2018, at
25 or near Anchorage, Alaska GABRIELLE R. LEDOUX, while acting as an accomplice,
26 solicited another person, and/or aided or abetted another person in planning for the other
27 person to intentionally make a false affidavit, swear falsely, or falsely affirm under an
oath required by Title 15, to wit: falsely filling out Simpson's voter registration

1 application.

2 All of which is a Class C Felony offense being contrary to and in violation of
3 AS 15.56.040 and against the peace and dignity of the State of Alaska.

4
5 **COUNT II:**

6 That in the Third Judicial District, State of Alaska, on or about June 17, 2018, at
7 or near Anchorage, Alaska GABRIELLE R. LEDOUX, while acting as an
8 accomplice, solicited another person, and/or aided or abetted another person in planning
9 for the other person to intentionally make a false affidavit, swear falsely, or falsely affirm
10 under an oath required by Title 15, to wit: falsely filling out Vaught's voter registration
11 application.

12 All of which is a Class C Felony offense being contrary to and in violation of
13 AS 15.56.040 and against the peace and dignity of the State of Alaska.

14
15 **COUNT III:**

16 That in the Third Judicial District, State of Alaska, on or about September 28,
17 2018, at or near Anchorage, Alaska GABRIELLE R. LEDOUX, while acting as an
18 accomplice, solicited another person, and/or aided or abetted another person in planning
19 for the other person to intentionally make a false affidavit, swear falsely, or falsely affirm
20 under an oath required by Title 15, to wit: falsely filling out Vaught's voter registration
21 application.

22 All of which is a Class C Felony offense being contrary to and in violation of
23 AS 15.56.040 and against the peace and dignity of the State of Alaska.

24
25 **COUNT IV:**

26 That in the Third Judicial District, State of Alaska, on or about August 21, 2018,
27 at or near Anchorage, Alaska, GABRIELLE R. LEDOUX, while acting as an
28 accomplice, solicited another person, and/or aided or abetted another person in planning

1 for the other person to intentionally make a false affidavit, swear falsely, or falsely affirm
2 under an oath required by Title 15, to wit: signing under oath when voting a questioned
3 ballot in the 2018 primary election.

4 All of which is a Class C Felony offense being contrary to and in violation of
5 AS 15.56.040 and against the peace and dignity of the State of Alaska.

COUNT V:

That in the Third Judicial District, State of Alaska, on or about November 6, 2018,
at or near Anchorage, Alaska, GABRIELLE R. LEDOUX, while acting as an
accomplice, solicited another person, and/or aided or abetted another person in planning
for the other person to intentionally make a false affidavit, swear falsely, or falsely affirm
under an oath required by Title 15, to wit: signing under oath when voting a questioned
ballot in the 2018 general election.

All of which is a Class C Felony offense being contrary to and in violation of
AS 15.56.040 and against the peace and dignity of the State of Alaska.

COUNT VI:

That in the Third Judicial District, State of Alaska, on or about July 18, 2018, at or
near Anchorage, Alaska, GABRIELLE R. LEDOUX, while acting as an
accomplice, solicited another person, and/or aided or abetted another person to register to
vote without being entitled to register to vote under AS 15.07.030.

All of which is a Class A Misdemeanor offense being contrary to and in
violation of AS 15.56.050(a)(1) and against the peace and dignity of the State of Alaska.

COUNT VII:

That in the Third Judicial District, State of Alaska, on or about July 18, 2018, at or
near Anchorage, Alaska, GABRIELLE R. LEDOUX, while acting as an accomplice,

1 solicited another person, and/or aided or abetted another person to knowingly make a
2 material false statement while applying for voter registration or reregistration.

3 All of which is a Class A Misdemeanor offense being contrary to and in
4 violation of AS 15.56.050(a)(2) and against the peace and dignity of the State of Alaska.

5
6 **COUNT VIII:**

7 That in the Third Judicial District, State of Alaska, on or about July 18, 2018, at
8 or near Anchorage, Alaska, GABRIELLE R. LEDOUX knowingly solicited or
9 encouraged, directly or indirectly, a registered voter who is no longer qualified to vote
10 under AS 15.05.010, to vote in an election, to wit: Lisa Simpson.

11 All of which is a Class A Misdemeanor offense being contrary to and in
12 violation of AS 15.56.035 and against the peace and dignity of the State of Alaska.

13
14 **COUNT IX:**

15 That in the Third Judicial District, State of Alaska, on or about August 19, 2018, at
16 or near Anchorage, Alaska, GABRIELLE R. LEDOUX, knowingly solicited or
17 encouraged, directly or indirectly, a registered voter who is no longer qualified to vote
18 under AS 15.05.010, to vote in an election, to wit: Caden Vaught in the 2018 primary
19 election.

20 All of which is a Class A Misdemeanor offense being contrary to and in
21 violation of AS 15.56.035 and against the peace and dignity of the State of Alaska.

22
23 **COUNT X:**

24 That in the Third Judicial District, State of Alaska, on or about September 25,
25 2018, at or near Anchorage, Alaska, GABRIELLE R. LEDOUX, knowingly solicited or
26 encouraged, directly or indirectly, a registered voter who is no longer qualified to vote
27 under AS 15.05.010, to vote in an election, to wit: Caden Vaught in the 2018 general
election.

1 All of which is a Class A Misdemeanor offense being contrary to and in
2 violation of AS 15.56.035 and against the peace and dignity of the State of Alaska.

3 COUNT XI:

4 That in the Third Judicial District, State of Alaska, on or about July 18, 2018, at or
5 near Anchorage, Alaska, GABRIELLE R. LEDOUX, knowingly solicited or encouraged,
6 directly or indirectly, a registered voter who is no longer qualified to vote under AS
7 15.05.010, to vote in an election, to wit: Patrick Simpson in the 2018 primary election.

8 All of which is a Class A Misdemeanor offense being contrary to and in
9 violation of AS 15.56.035 and against the peace and dignity of the State of Alaska.

10 COUNT XII:

11 That in the Third Judicial District, State of Alaska, on or about September 25,
12 2018, at or near Anchorage, Alaska, GABRIELLE R. LEDOUX, knowingly solicited or
13 encouraged, directly or indirectly, a registered voter who is no longer qualified to vote
14 under AS 15.05.010, to vote in an election, to wit: Patrick Simpson in the 2018 general
15 election.

16 All of which is a Class A Misdemeanor offense being contrary to and in
17 violation of AS 15.56.035 and against the peace and dignity of the State of Alaska.
