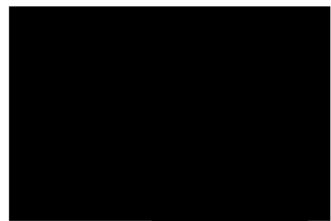

ON 12/30/2023 AT APPROXIMATELY 2252 HOURS, I WAS DISPATCHED TO 1200 13TH, AVENUE NORTH, CITY OF LAKE WORTH BEACH, PALM BEACH COUNTY, FLORIDA IN REFERENCE TO A DECEASED PERSON.
 ON MY ARRIVAL, I MET WITH CORINA BRYAN (07/12/1997) WHO TOLD ME THAT SHE LIVES WITH A ROOMMATE AND LEFT FOR THE HOLIDAYS ON 12/19/2023, RETURNED TODAY 12/30/2023 AND DID NOT SEE HER ROOMMATE CINDY MORGAN (09/29/1951) WHEN SHE RETURNED. BRYAN SAID THAT SHE KNOCKED ON MS. MORGAN'S DOOR AND GOT NO

RESPONSE. BRYAN SAID SHE THOUGHT THERE WAS AN ODOR COMING FROM CINDY'S APARTMENT. MS. BRYAN SAID THAT SHE LAST SAW CINDY ON 12/19/2023 AROUND 1900 HOURS.

I KNOCKED ON MS. MORGAN'S DOOR AND GOT NO RESPONSE. BASED ON THE FACT THAT THERE WAS NO ANSWER TO KNOCKING ON THE DOOR, I CONTACTED THE OWNER OF THE PROPERTY SHERRYL A. DELISSER (01/25/1968) AND REQUESTED PERMISSION TO FORCE ENTRY INTO THE APARTMENT. I CONTACTED SERGEANT MERCIER ID# 8236 AND INFORMED HIM OF THE INCIDENT. SGT. MERCIER RESPONDED TO THE SCENE. PALM BEACH COUNTY FIRE RESCUE WERE REQUESTED TO THE RESIDENCE AND FORCED ENTRY TO THE APARTMENT. PBCFR RUN# (23-155448), ENGINE #93, ON ENTRY, FOUND A WHITE FEMALE LYING ON THE BATHROOM FLOOR LOCATED INSIDE THE APARTMENT AND PRONOUNCED THE FEMALE DECEASED AT 2203 HOURS ON 12/30/2023. THE FEMALE IS LYING ON HER BACK WITH HER LEFT ARM COVERING HER FACE. THE FEMALE IS WEARING A BLACK SHIRT AND NO PANTS. IN THE TOILET THERE IS EVIDENCE OF VOMITING AND NO SIGNS OF FOUL PLAY. THERE IS OBVIOUS SIGNS OF DECOMPOSITION WHICH MAKE IT DIFFICULT TO DETERMINE ANY ADDITIONAL TRAUMA.

I CONTACTED MS. MORGAN'S DOCTOR AND INFORMED HER OF MS. MORGAN'S DEATH. DR. DUHANEY AGREED TO SIGN THE DEATH CERTIFICATE.

I SPOKE WITH THE PALM BEACH COUNTY MEDICAL EXAMINER'S OFFICE AND INFORMED THEM OF THE INCIDENT AS WELL AS PROVIDED A DEATH INVESTIGATION FORM. THE PBCME DECLINED TO RETRIEVE THE DECEASED AND REQUESTED THAT ALL COUNTY FUNERAL HOME BE CONTACTED FOR REMOVAL.

REMOVAL OF SOUTH FLORIDA A SUBCONTRACTOR OF ALL COUNTY FUNERAL HOME ARRIVED ON SCENE AND REMOVED THE DECEASED.

I CONTACTED DONNA CHEATHAM (07/14/1959) WHO IS LISTED AS THE EMERGENCY CONTACT ON MS. MORGAN'S FLORIDA IDENTIFICATION CARD AND INQUIRED ABOUT MS. MORGAN'S RELATIVES OR FAMILY MEMBERS. MS. CHEATHAM SAID THAT SHE WAS AWARE OF EX-HUSBANDS, BUT NO CHILDREN. I ASKED ABOUT THAT LAST TIME MS. CHEATHAM SPOKE WITH MS. MORGAN TO WHICH SHE REPLIED "IT'S BEEN YEARS". MS. CHEATHAM DID SAY THAT SHE FOLLOWED MS. MORGAN ON FACEBOOK AND SAW A POST FROM THE 25TH. THE RESIDENCE IS A SINGLE FAMILY HOME DIVIDED INTO TWO SEPARATED LIVING SPACES. MS MORGAN LIVED IN A SPACE JUST SOUTH OF THE KITCHEN. THE DOOR TO THAT SPACE WAS LOCKED FROM THE INSIDE OF THE APARTMENT.

I REMOVED FOUR BOTTLES OF PRESCRIPTION MEDICATION FROM THE DECEASED PERSONNEL SPACE TO INCLUDE: MS. MORGAN'S UNITED STATES PASSPORT AND THE FOLLOWING:
