**SUBJECT:** Staff Report, Complaint 24-04-CD, *907 Initiative v. Stanley Wright*

### **SUMMARY OF COMPLAINT**

The Complaint alleges that the Respondent failed to timely disburse remaining campaign funds after the 2022 state election and that he failed to file accurate 7 Day Primary, 30 Day General, 7 Day General, and Year End Campaign Disclosure Reports during his 2022 campaign.<sup>1</sup>

Complainant filed an addendum to the complaint on October 17, 2024, noting that the Respondent had amended the preceding reports as well as his 2024 Year Start and 30 Day Primary Reports on the date that the complaint was filed, September 19, 2024.<sup>2</sup> Complainant further notes that despite the corrections, the 2022 Year End is still inaccurate which, in turn, calls into question the accuracy of each subsequent report for his 2024 campaign.

### **SUMMARY OF ANSWERS TO COMPLAINT**

The Respondent did not provide an answer to the complaint.

## **FACTS**

Stanley Wright was a candidate for State House in the 2022 state election. During his campaign he filed a 30 Day Primary,<sup>3</sup> 7 Day Primary,<sup>4</sup> 30 Day General,<sup>5</sup> 7 Day General,<sup>6</sup> and Year End Campaign Disclosure Reports.<sup>7</sup> Mr. Wright is campaigning for re-election to the State House in the current 2024 state election and has filed 2024 Year Start,<sup>8</sup> 30 Day Primary,<sup>9</sup> 7 Day Primary,<sup>10</sup> and 30 Day General Campaign Disclosure Reports.<sup>11</sup>

After the 2022 election, Mr. Wright filed a Year End Report disclosing an ending balance (closing cash on hand) of \$2,061.99.<sup>12</sup> However, because prior reports failed to correctly carry over closing cash on hand (CCOH) amounts to the beginning cash on hand (BCOH) amounts on the subsequent reports, this amount is not correct. Based on his reported beginning cash on hand for the 2022 campaign (\$1,097.33), his total reported income (\$34,762.49) and expenditures (\$30,704.86), it appears the 2022 campaign had a surplus of \$5,154.96.

A review of the 2022 campaign's bank records indicate a beginning balance of \$1,186.33 at the start of the 2022 campaign with deposits to the account of \$30,746.90 and expenditures in the amount of \$29,882.69 flowing from the account. It is not clear whether the discrepancies are attributable to processing fees for credit card contributions that are taken prior to the deposits into the campaign account, whether the campaign simply over-reported contributions and expenditures, whether there were funds that did not flow through the campaign account, a combination of these things or something else altogether.

In any event, it is clear that the campaign failed to reconcile its reporting and failed to accurately disclose its financial activity.

### **LAW AND ANALYSIS**

Campaigns are required to timely file accurate campaign disclosure reports disclosing contributions and expenditures.<sup>13</sup> Mr. Wright’s 2022 reports were amended several times throughout the 2022 campaign and more recently once this complaint was filed. The amendments purportedly accounted for previous reporting discrepancies but failed to carry over CCOH amounts to the next report as a BCOH amount rendering the reports inaccurate. Additionally, the reported activity does not correlate with the campaign’s bank records further calling into question the accuracy of the reports.

By law, candidates are required to disburse leftover funds no later than February 1 after an election.<sup>14</sup> There are a variety of options to disburse such amounts, including the transfer of funds, within applicable limits, to a future campaign account or, where applicable, to a public office expense term account. Mr. Wright did not avail himself of any of these options and continued to show a remaining surplus on his 2022 Year End Report. Funds remaining after February 1 must be forfeited to the State of Alaska.<sup>15</sup> In several instances, the Commission has required such forfeitures when funds have not been timely disbursed.<sup>16</sup>

### **CONCLUSION**

Respondent failed timely disburse leftover campaign funds after the 2022 election in violation of AS 15.13.116. Based on the reported contributions and expenditures of the

campaign the surplus of \$5,154.96 should be forfeited to the State of Alaska. The Respondent also violated AS 15.13.040 and AS 15.13.100 by failing to timely file accurate reports for the periods detailed below.

**MAXIMUM CIVIL PENALTIES**

The maximum civil penalty for each of the reporting violations, other than the 7 day reports, is \$50 per day for each day the violation continues; for 7 day reports, the maximum civil penalty amount is \$500 per day through the date of the election and \$50 per day thereafter.<sup>17</sup> For purposes of calculating the maximum civil penalties for the reporting violations, the accrual of penalties began the day after the report was due and was tolled on September 19, 2024, the day the Complaint was filed. The maximum penalty amounts for each of the violations are as follows:

**MITIGATION AND RECOMMENDATION**

When staff assesses a penalty, the starting point for calculating the penalty is 2 AAC 50.855. For the 2022 campaign’s 30 Day Primary Report, the regulation enables staff to reduce the penalty by 50% because this was respondent’s first violation.<sup>18</sup> From

there, mitigation may be applied for a greater than 50% reduction or waived entirely if the penalty is significantly out of proportion to the degree of harm suffered by the public.<sup>19</sup> A civil penalty is significantly out of proportion if it exceeds the value of the transactions that were reported late.

Here, for every report, except for the 2024 campaign’s 2024 30 and 7 day primary reports, the total reported activity is significantly less than the maximum penalty amount. For these reporting errors staff recommends a 98% reduction to the maximum penalty. Staff finds no applicable mitigation criteria for the 2024 30 Day or 7 Day Reports. This results in a penalty of \$11,442 for the reporting violations. Staff also recommends the 2022 campaign forfeit its leftover funds in the amount of \$5,154.96 but recommends no penalty because it does not appear that respondent was made aware that he needed to take action.

## Complaint against Stanley Wright

### Alleged Violations

**AS 15.13** Failure to file accurate reports

**AS 15.13.116** Disbursement of campaign assets after election

### Facts

1. Stanley Wright failed to file compliant reports during his 2022 State House campaign.
2. At the conclusion of his 2022 campaign, Stanley Wright did not create a Future Campaign Account.
3. At the start of his 2024 campaign, Stanley Wright brought forward a non-zero beginning cash on hand (BCOH) amount.

### 2022 Campaign

- On his **2022 Year End Report** filed on 2/15/23, Stanley Wright **did not transfer money to a Future Campaign Account with unused campaign contributions.** (Exhibit 1, pages 2 - 5) As a State House candidate, he could have transferred up to \$5000.

### 2024 Campaign

- Stanley Wright filed a **Letter of Intent** on **11/15/23** to run for reelection to the State House in 2024. (Exhibit 2)
- He filed a **Year Start Report** on **2/13/24** showing a **beginning cash on hand (BCOH) of \$0.** (Exhibit 3)
- The very next day (2/14/24), Wright **amended** his 2024 Year Start Report to show a beginning cash on hand (BCOH) of **\$7,886.74.** The purpose of the amendment was to **“include previous campaign funds”** (Exhibit 4)
- Given that the Year Start Report was his first report for the 2024 campaign and he did not create a Future Campaign Account from his 2022 campaign, the **BCOH should be \$0.** [NOTE: *If he did have a Future Campaign Account*, the maximum transfer for a previous House candidate is \$5,000. His listed **BCOH of \$7,886.74** would be more than 1.5 times the allowable amount.]

### How did Stanley Wright arrive at a BCOH of \$7,886.74?

Mr Wright’s 2024 Year Start Report’s amended BCOH of \$7,886.74 is an amount we’ve not seen before in his reporting. Where did that come from?



Wright's 7 Day (Primary), 30 Day (General), 7 Day (General) and Year End Reports for his 2022 campaign all have incorrect Beginning Cash on Hand amounts. The CCOH (Closing Cash on Hand) on an APOC report and the BCOH (Beginning Cash on Hand) on the next sequential report should be equal. The matching colors below indicate boxes which should have the same amount. None do. [NOTE: Data downloaded from Stanley Wright's 2022 APOC reports.]

As a result of the above errors, Stanley Wright's 2022 Year End Report's surplus of **\$2,061.99** is incorrect.

To arrive at the correct surplus,

- Sum all reported amounts in row 2 above to arrive at Total Income.
- Sum all reported amounts in row 3 above to arrive at Total Expenses.
- Subtract Total Expenses from the Total Income and you get \$7,886.74. (See Box A and Box B on Exhibit 1, page 1.)

### Conclusion

Stanley Wright violated AS 15.13 when he improperly reported his beginning cash on hand four times in the 2022 campaign cycle. He then violated AS 15.13.116 when he failed to properly disburse his remaining cash on hand within the required timeframe. Due to his failure to create a Future Campaign Account with 2022 unused campaign contributions, Stanley Wright should not be allowed to bring any of that money forward to his 2024 campaign. Furthermore, he should have to forfeit the entirety of those funds (\$7,886.74) to the State of Alaska per AS 15.13.116(c).

The 2022 Amended 7-Day (General) Report (Exhibit 1) and the 2022 amended Year-End Report (Exhibit 2) summaries are below. The CCOH on the 7-Day (General) in Column 1 should become the BCOH on the Year End in Column 2, but it doesn't (\$21,248.67 versus \$18,155.70). Therefore, the CCOH of **\$2,061.99** on the Year End Report is not accurate. Assuming that the amended 7-Day General Report is accurate and we use \$21,248.67 as the BCOH on the amended Year End Report, the CCOH on the Year End Report should be **\$5,154.96**.

Mr. Wright then carries the inaccurate CCOH from his amended 2022 Year-End Report (Column 1 below; Exhibit 2) to the BCOH of his 2024 amended (as of 9/19/24) Year-Start Report (Column 2; Exhibit 3). By doing so, the CCOH and every subsequently filed report is inaccurate.

It's clear to see that even after this complaint was filed, Mr. Wright's APOC reports continue to be wildly inaccurate. At the very least, Mr. Wright should forfeit his 2022 surplus. The inaccuracy of these filings, but the original reports and the amended reports, call into question the accuracy of all of Mr. Wright's reports. APOC should request bank records to determine exactly what the surplus was, and any other inaccuracies that aren't visible in his APOC filings. In addition, he should be fined for the grossly inaccurate 2024 reporting that followed, independent of the erroneous surplus.

I find the following quote from page 18 of the Commission's Final Order in 21-01-CD to be applicable in this case:

***"The public deserves timely and accurate reporting of a campaign's financial activity."***

**Sec. 15.13.116. Disbursement of campaign assets after election.**

(a) A candidate who, after the date of the general, special, municipal, or municipal runoff election or after the date the candidate withdraws as a candidate, whichever comes first, holds unused campaign contributions shall distribute the amount held on February 1 for a general election or within 90 days after a special election. The distribution may only be made to

(1) pay bills incurred for expenditures reasonably related to the campaign and the winding up of the affairs of the campaign, including a victory or thank you party, thank you advertisements, and thank you gifts to campaign employees and volunteers, and to pay expenditures associated with post-election fund raising that may be needed to raise funds to pay off campaign debts;

(2) make donations, without condition, to

(A) a political party;

(B) the state's general fund;

(C) a municipality of the state; or

(D) the federal government;

(3) make donations, without condition, to organizations qualified as charitable organizations under 26 U.S.C. 501(c)(3) if the organization is not controlled by the candidate or a member of the candidate's immediate family;

(4) repay loans from the candidate to the candidate's own campaign under AS 15.13.078(b);

(5) repay contributions to contributors, but only if repayment of the contribution is made pro rata in approximate proportion to the contributions made using one of the following, as the candidate determines:

(A) to all contributors;

(B) to contributors who have contributed most recently; or

(C) to contributors who have made larger contributions;

(6) establish a fund for, and from that fund to pay, attorney fees or costs incurred in the prosecution or defense of an administrative or civil judicial action that directly concerns a challenge to the victory or defeat of the candidate in the election;

(7) transfer all or a portion of the unused campaign contributions to an account for a future election campaign; a transfer under this paragraph is limited to

(A) \$50,000, if the transfer is made by a candidate for governor or lieutenant governor;

(B) \$10,000, if the transfer is made by a candidate for the state senate;

(C) \$5,000, if the transfer is made by a candidate for the state house of representatives; and

(D) \$5,000, if the transfer is made by a candidate for an office not described in (A) – (C) of this paragraph;

(8) transfer all or a portion of the unused campaign contributions to a public office expense term account; a transfer under this paragraph is subject to the following:

(A) the authority to transfer is limited to candidates who are elected to

the state legislature;

(B) the public office expense term account established under this paragraph may be used only for expenses associated with the candidate's serving as a member of the legislature;

(C) all amounts expended from the public office expense term account shall be annually accounted for under AS 15.13.110(a)(4);

(D) a transfer under this paragraph is limited to \$5,000 multiplied by the number of years in the term to which the candidate is elected plus any accumulated interest; and

(E) unused campaign contributions transferred under this paragraph must be disposed of as provided in (2), (3), or (5) of this subsection at the end of the term of office immediately following the campaign for which the contributions were received; and

(9) transfer all or a portion of the unused campaign contributions to a municipal office account; a transfer under this paragraph is subject to the following:

(A) the authority to transfer is limited to candidates who are elected to municipal office, including a municipal school board;

(B) the municipal office account established under this paragraph may be used only for expenses associated with the candidate's serving as mayor or as a member of the assembly, city council, or school board;

(C) all amounts expended from the municipal office account shall be annually accounted for under AS 15.13.110(a)(4);

(D) a transfer under this paragraph is limited to \$5,000; and

(E) unused campaign contributions transferred under this paragraph must be disposed of as provided in (2), (3), or (5) of this subsection at the end of the term of office immediately following the campaign for which the contributions were received.

(b) After a general, special, municipal, or municipal runoff election, a candidate may retain the ownership of one computer and one printer and of personal property, except money, that was acquired by and for use in the campaign. The current fair market value of the property retained, exclusive of the computer and printer, may not exceed \$5,000. All other property shall be disposed of, or sold and the sale proceeds disposed of, in accordance with (a) or (c) of this section. Notwithstanding any other provision of this chapter,

(1) a candidate may (A) retain a bulk mailing permit that was paid for with campaign funds, and (B) use personal funds, campaign funds, or unused campaign contributions transferred to a public office expense term account under (a)(8) of this section to pay the continuing charges for the permit after the election; money used to continue the life of the permit is not considered to be a contribution under this chapter; in addition to any other use permitted under this chapter, during the candidate's term of office, the candidate may use the bulk mailing permit for mailings associated with service in the office to which the candidate was elected; during the candidate's term of office, if the candidate files a declaration of candidacy or the document necessary to permit the candidate to incur election-related expenses under AS 15.13.100 for the same or a different elective office, the candidate may also use the bulk mailing permit in that election campaign;

(2) a candidate may retain campaign photographs and use the photographs for any purpose associated with service in the office to which the candidate was elected;

(3) a candidate may retain seasonal greeting cards purchased with campaign funds;  
and

(4) campaign signs prepared for an election that has already taken place have no monetary value and may be retained or disposed of at the candidate's discretion.

(c) Property remaining after disbursements are made under (a) – (b) of this section is forfeited to the state. Within 30 days, the candidate shall deliver the property to the Department of Revenue. The Department of Revenue shall deposit any money received into the general fund and dispose of any other property in accordance with law.
