SUBJECT: Staff Report, Complaint 24-05-CD, *907 Initiative v. David Nelson*

SUMMARY OF COMPLAINT

The Complainant alleges that the Respondent failed to timely disburse remaining campaign funds to a future campaign account after the 2022 state election and that his 2024 campaign carried forward leftover funds that exceeded the allowable amount.¹

The Complainant filed an addendum to the complaint on October 14, 2024, noting that the Respondent had amended many of his 2022 reports, along with his 2024 30 Day Primary Report after the complaint was filed and that it was clear that his 2022 reporting was grossly inaccurate.²

SUMMARY OF ANSWERS TO COMPLAINT

The Respondent asserts³ there was no violation of AS 15.13.116, stating it was his intent to place the 2022 surplus fund into a Future Campaign Account (FCA), but that when filing after the 2022 campaign the only report option in the APOC online filing system was a Year End Report. Respondent states he believed it was the required report and filed it. Respondent also states that, while in the process of correcting and amending his 2022 reports, the campaign discovered that some expenses had not been disclosed in the original reports. Respondent states that these errors were self-reported to APOC staff telephonically.

FACTS

David Nelson was a candidate for the State House in 2022 state election. During his campaign he filed a Year Start,⁴ 30 Day Primary,⁵ 7 Day Primary,⁶ 30 Day General,⁷ 7 Day General Campaign Disclosure Reports.⁸

In February 2023, after the 2022 election, the campaign filed a Year End Report disclosing an ending balance (closing cash on hand) of \$11,439.70.⁹ In February 2024, the campaign filed another Year End Report disclosing bank fees in the amount of \$144 and a closing cash on hand of \$11,295.70.¹⁰

Mr. Nelson is campaigning for re-election to the State House in the current 2024 state election. His first report for the 2024 campaign cycle was his 30 Day Primary Campaign Disclosure Report.¹¹ The report disclosed a beginning cash on hand of \$11,295.70 and a closing cash on hand of \$15,062.87. His next report, the 7 Day Primary Report, disclosed a beginning cash on hand of zero and a closing deficit of -\$952.94.¹² This was followed by his 30 Day General Report, which disclosed a beginning cash on hand of \$3,583.03.¹³

After the complaint was filed, the campaign amended all but two of its 2022 reports.¹⁴ While several were amended to correct the financial summaries, the 7 Day Primary Report¹⁵ was amended to disclose over \$3,500 in expenditures that had not been previously disclosed and the Year End Report¹⁶ disclosed nearly \$8,000 in additional

expenditures that had not been disclosed. After the amendments, the campaign reported a total of \$38,265 in contributions and \$38,307.32 in expenditures, inclusive of a \$882.80 transfer to a future campaign account.¹⁷ But a review of the 2022 campaign’s bank records indicated deposits to the account of 42,816.68 and expenditures in the amount of \$41,613.15 flowing from the account.

LAW AND ANALYSIS

Campaigns are required to timely file accurate campaign disclosure reports disclosing contributions and expenditures.¹⁸ The campaign’s 2022 reports were inaccurate. They were only amended after this complaint was filed and showed substantial changes in the reported expenditures. Perhaps more concerning, the reported activity does not correlate with the campaign’s bank records, further calling into question the accuracy of the campaign’s reporting.

By law, candidates are required to disburse leftover funds no later than February 1 after an election.¹⁹ There are a variety of options to disburse such amounts, including the transfer of funds, within applicable limits, to a future campaign account.²⁰ To do this, a candidate would disclose the disbursement on their final report showing it was made to a future campaign account.²¹ Mr. Nelson did not report any disbursements and continued to show a remaining surplus on his 2022 Year End Report—a surplus that also exceeded the \$5,000 limit on the amount he was permitted to transfer to a future campaign account.²²

By statute, funds remaining after February 1 must be forfeited to the State of Alaska.²³ In several instances, the Commission has ordered such forfeitures when funds

have not been timely disbursed.²⁴

CONCLUSION

Respondent failed to timely disburse leftover campaign funds after the 2022 election in violation of AS 15.13.116. Based on the campaign’s bank records, the campaign had a surplus of \$1,373.28 that should have been forfeited to the State of Alaska. The Respondent also violated AS 15.13.040 and AS 15.13.110 by failing to file accurate reports for the periods detailed below.

MAXIMUM CIVIL PENALTIES

The maximum civil penalty for each of the reporting violations, other than the 7 day reports, is \$50 per day for each day the violation continues; for 7 Day reports, the maximum civil penalty amount is \$500 per day through the date of the election and \$50 per day thereafter.²⁵ For purposes of calculating the maximum civil penalties, the accrual of penalties began the day after the report was due and was tolled on September 19, 2024, the date the Complaint was filed. The computed maximum penalty amounts for each of the violations are as follows:

MITIGATION AND RECOMMENDATION

When staff assesses a penalty, the starting point for calculating the penalty is 2 AAC 50.855. Here, because the Respondent had been a candidate in prior elections and also had previous late filings, staff finds no applicable reductions.²⁶

A civil penalty may be reduced by a percentage greater than 50% or waived entirely if the penalty is significantly out of proportion to the degree of harm suffered by the public.²⁷ A civil penalty is significantly out of proportion if it exceeds the value of the transactions that were reported late.

Here, for every report, except for the 2024 30 Day Primary Report, the total reported activity is significantly less than the maximum penalty amount. For these reporting errors staff recommends a 98% reduction of the maximum penalty. Staff finds no applicable mitigation criteria for the 2024 30 Day Primary Report.

Complaint against David Nelson

Alleged Violations

AS 15.13.116 Disbursement of campaign assets after election

Facts

1. At the conclusion of his 2022 campaign, David Nelson did not create a Future Campaign Account.
2. At the start of his 2024 campaign, he brought forward a non-zero beginning cash on hand (BCOH) amount.

Background

2022 Campaign

- David Nelson sought reelection to the Alaska State House in 2022. On his **Year End Report** dated **2/15/23**, he did not transfer money to a Future Campaign Account with unused campaign contributions. (Exhibit 1, page 2) As a State House candidate, he could have transferred up to \$5000.

2024 Campaign

- David Nelson filed a **Letter of Intent** on **4/29/24** to run for the State House in 2024. (Exhibit 2)
- David Nelson filed a **30 Day (Primary) Report** on **7/22/24** showing a **beginning cash on hand (BCOH) of \$11,295.70** (Exhibit 3)
- Given that the 30 Day (Primary) Report was his first report for the 2024 campaign, the **BCOH should be \$0** since he did not have a Future Campaign Account. [NOTE: *If he did have a Future Campaign Account*, the maximum transfer for a previous House candidate is \$5,000. His listed BCOH of \$11,295.70 would be more than 2.25 times the allowable amount.]

Conclusion

Due to his failure to create a Future Campaign Account with 2022 unused campaign contributions, David Nelson should not be allowed to bring any of that money forward to his 2024 campaign. Furthermore, he should have to forfeit the entirety of those funds to the State of Alaska per AS 15.13.116(c). If APOC allows David Nelson to keep some of his funds from 2022, he should be required to forfeit, at a minimum, \$6,295.70 which is the amount that is over the allowable transfer from a Future Campaign Account for a House candidate.

Complainant's Response to Respondent's Response (24-05-CD)

This memo is a response to David Nelson's response to a complaint I filed on Sept. 19, 2024.

Mr. Nelson timely filed his initial 2022 Year End Report on 2/15/23. The listed CCOH was **\$11,439.70** (See below). The Respondent did not file any amendments to that report until after this complaint was filed on 9/20/24.

The first amended 2022 Year End Report was filed 9/22/24 (two days after the complaint was filed), showing a *tenfold increase in the previously reported expenses*, going **from \$767.00 to \$7,743.90**. Respondent states in his response:

" ... so any issues with disclosure to the public would have occurred after the 2022 November election."

That is indeed the issue. In fact, the disclosure was made more than **19 months after required by law**.

A second amendment on 9/22/24 created a Future Campaign Account containing \$882.80, but the deadline to create an FCA for a 2022 campaign had long since passed. In fact, the 2024 campaign was post-Primary at that date.

Mr. Nelson is a candidate again in 2024. His first report, the 30-Day (Primary), was filed on 7/22/24 (see the totals below). As recently as late July 2024, Mr. Nelson reported his BCOH was \$11,295.70. After receiving this complaint, he filed an amended report that showed a BCOH that was \$10,700.90 less than what he reported exactly two months previously. (See row 1, Exhibit 4 vs Exhibit 5)

The filed complaint focused on a prohibited surplus in 2022. In reviewing the many amendments recently made to his reports, it is evident that Mr. Nelson's originally filed 7-Day (Primary), 30-Day (General), 7-Day (General) and Year-End reports for his 2022 campaign were grossly inaccurate, as was


his 30-Day (Primary) Report for 2024. These inaccuracies run afoul of the law and create an unfair advantage, and the extent of inaccurate reporting begs for a more serious inquiry into Mr. Nelson's reports. It's critical that APOC address these violations to protect fair elections.

When filing our end-of-the-year report at the end of the 2020 campaign, the APOC website gave a report type of "2021 future campaign account." When we attempted to file the same report in 2022, the only option was a "2023 - Year End report." Figuring that this was the required report, that is what we filed it as. APOC staff notified us of this error on August 15, 2024. We worked to amend all our reports to correct this issue. The leftover money from the 2022 election was for a future campaign account. The system didn't show that as a filing option. The APOC online forms will often give errors or will not let us submit when information is missing or incorrect. The fact that the form let us proceed was the reason we believed we were filing the correct form.

While correcting these reports, we discovered some expenses that were missed in our 2022 reports. This error was promptly corrected and self-reported to APOC staff via phone call when all issues were corrected. All the issues were with expenses. No contributions were missing from the reports. A majority of the corrections were made in the last report, so any issues with disclosure to the public would have occurred after the 2022 November election. We are willing to provide documentation to APOC staff regarding this separate issue.
