About Property Tax Records September 29, 2023

The Fractal team is building an online database of ALL property tax records for every one of the 3,200 counties in the U.S.

Frequently Asked Questions:

What is the property tax database?

Every county has a database of properties and their tax assessments. This database is used every day by banks and real estate agents to build comps for real estate transactions. These databases are always at the county level. They are usually in an office called the Tax Assessor. Sometimes they are in an office called Treasurer.

Why do you need the property tax database?

The property tax database is the most pristine, accurate database of every address, building or vacant lot in a county. It is current because most counties require building permits for new construction or additions. Thus, those are reflected in that DB.

What do you use the property tax database for?

The property tax database shows the current use of a building, its square footage, number of baths, bedrooms etc. In many cases it shows the business in the current building.

These tax rolls are official government documents. They can be cross searched against voter registrations, Medicaid files, WIC and other state databases to determine if an address is clearly incorrect (i.e. voters living in a Walmart).

Cross searching the property tax records against other government files enables states to clean and reconcile their state program rolls.

What do I ask for to get the property tax database?

The property tax database usually comes in one of two formats.

Commonly, citizens can log on from their computer, input a property address and find a specific property's record. In more advanced states, there may be a URL enabling the entire database to be downloaded and searched.

The Fractal team needs the entire database, not access to the one-at-a-time database.

My assessor said they will not give out phone numbers or names from the tax database.

What do I say?

Some counties do not provide personal information. Other counties make the recipient agree not to sell products to the people on the tax database using its information.

Fractal does not care about the names of the owners or their phone numbers. Even if that information makes it to the database, Fractal does not use it.

Thus, feel free to agree with the Assessor to take the database without such information in it.

What is the cost of the property tax database?

The costs are often no charge or sometimes around \$100. They are typically not expensive.

What format do I ask for?

You are asking for an electronic copy of the database. Many counties are ancient in their technology and have 30-year-old databases like dBase and others.

Fractal can take any electronic format. Our preferred formats are .CSV, SQL, relational.

How do I know I received the right data?

Fractal will ingest the data and immediately let you know if anything is missing.

Most assessors have never been asked for this information. In many cases, fields are left off and the Fractal team then engages with you noting what might have been left out.

How do I get the data to Fractal?

If there is a URL, send that to Fractal. If a database is given to you, set up a Google drive and put it there and Fractal will take it from there.

What information do I include?

You should include any information about the location of the data. What was the county, state? What was the URL? What date was it downloaded or received?

Do I need to do a FOIA request?

Often yes. Fractal provides a template suggested format. Current counties responded very quickly with little resistance – often with great cooperation.

How often should I get copies of the county tax records?

Fractal tries to update the county records once every 6 months. In some counties, there are on-line systems for the county tax records and the Fractal team will update them more often.

Can I get multiple counties' tax databases?

If you can do this, you should. Fractal has teams in North Carolina, Georgia, Florida and other states collecting all the records across every county.

Can I get access to the Fractal property tax database?

If you contribute to the system, you will be given a log on and training. You will be able to run your analysis across all counties in your state for as long as Fractal offers such a service.

My assessor's office wants to know what fields I need?

Sometimes the assessor office does not understand “the entire database.” They may ask for fields needed. Try to explain that we need the entire database. In several counties, the Fractal team created a typical list of needed fields for such situations.

Does the Assessor resist giving out this data?

Typically, when one asks for **voter** records, the county person knows there is some political motive that may cause them some grief. They may be resistant.

But assessors tend to not be wrapped up in current controversies about voter fraud. They usually are very happy to provide the property tax data.

Are there computer services for these tax records?

Some counties use a service that manages these tax records. In several states, the service was pleased to provide Fractal access to over a dozen counties at once. You should ask if there is such a service and they may be the one to contact.

My Assessor said they need to do a search. What should they search for?

Sometimes the Assessor's IT person thinks they need to do a search on fields provided by the requesting person. The first response should be to ask for the entire database in electronic format.

If that fails, the Fractal team will provide a list of the most common search terms.

Why hasn't this database been built before?

These databases are mindlessly complex. Some will have 100 to 120 columns of information. Every county has a different term or number for "single family residence."

There were no computer systems powerful enough to cross search all these fields, in different formats, before Fractal.

Minimum Values For Real Estate Property Tax Records

The information needed is property tax records as in real estate. We do not seek information about cars, boats or non-real estate.

The fields that we are interested in are the following:

MUST HAVE (1 & 2)

1) property full address (street # and name, city, state, zip) -- this is often referred to as the "situs address"

2) property type (at a minimum, an indicator of residential vs. commercial, etc.) -- if available, additional detail on property type (eg. single-family, multi-family, for residential and type of commercial property such as restaurant, movie theater, parking garage, etc.)

NICE TO HAVE

3) name of the property (especially if it is a commercial property -- eg. "WalMart", "7-11", etc.)

4) additional attributes (for example, square footage of the building, # of bedrooms, # of bathrooms, etc.)

5) name & address of owner(s)

6) latitude & longitude if available

In general, "more is better".

If possible, we would like a full dump of all of the property tax database. This will often be multiple tables from a relational database system. If that is difficult to get, then the fields above give us a good start on what we need.

Fractal Election Proof of Concept

This document outlines the deliverables, roles and responsibilities of the various parties for the Fractal Election Proof of Concept (PoC).

The **objective** of a PoC using Fractal technology is to introduce state governments and related organizations to Fractal technology, using the cleaning of election rolls as the **initial application**.

Fractal enables state governments to clean voter rolls and keep them clean – using other public databases to do so. **In Fractal, everything is 100% auditable.**

Fractal is a powerful tool for state governments to fight “identity fraud” where bad actors change names, addresses to hide in large complex databases, often illegally milking state programs.

Fractal is a very strong technology to manage, clean and maintain Medicaid, retirement, and other complex systems.

Fractal is a means for state governments to replace aging, complex, expensive systems with digitally transformed systems costing 1/10th those Fractal replaces.

1. Typical Proof of Concept

The typical Fractal PoC takes election rolls for a state and compares them with other public databases gaining insights not visible with most current technologies.

The voter rolls are gathered, usually multiple copies, from different dates.

Different date “snapshots” enable “time series analysis.” Time series analysis turns data snapshots into movies showing how voter rolls may have been manipulated to serve the interest of a certain candidate.

Voter rolls are then cross-searched with the property tax rolls from **one or two of the most populous counties**.

Property tax records are treasure troves of useful data.

They include year built, type of building, square footage, number of bedrooms, baths, secondary addresses and a host of other information.

Cross searching property tax rolls is not a one-time thing. Fractal is a REAL TIME, constant, 24/7 monitor of all activity on election rolls.

Every record change, even moving a comma, is auditable. Election officers can prove with 100% certainty, every change to every voter record is visible and legitimate.

The Fractal team usually adds **Federal Election Commission** data. FEC data is the list of all contributions to ALL federal candidates going as far back as 2019.

Cross-searching the FEC rolls for a state, the user finds all contributors who made X donations in X months. **Contribution mules** are quickly identified for law enforcement.

A state may choose to add databases that are not public.

A government running the PoC may choose to add DMV data, state contribution rolls or any other data pertaining to the people and programs in that state. Fractal will not make any of this public and any non-public data will be destroyed when the state requests it.

The Fractal team takes data provided by the state and builds a Fractal application.

Fractal applications are real-time, on-line and accessible from a phone or tablet.

Fractal usually takes about 2-3 weeks **FROM THE TIME IT RECEIVES THE DATA** to have a system up and running.

A Fractal system is never finished.

Even during the PoC, users may want to add data or modify or create queries. There are **NO LIMITATIONS** as to how much data can be added and analyzed.

A goal of the PoC is educating state executives and legislators as to how fast and inexpensively they can have their data queries answered – thus experiencing the disruptive benefits of Fractal.

State governments are under pressure to “digitally transform” operations. A Fractal PoC introduces state executives to how Fractal can do so at 1/10th the cost, and much faster, than traditional technology.

Once the Fractal system is complete, the Fractal team contacts the users and shows them the system giving them the initial training to run the queries and reporting. After a few days, the

users often want changes to the system to adapt to local requirements – Fractal does all it can to make system adaptations.

2. Gathering The Data

The state or organization requesting the PoC is responsible for gathering the data and furnishing it to Fractal. All costs for all data are the responsibility of those requesting the PoC.

Election databases: Usually there are election integrity groups with copies of election rolls dating back several years. Those are excellent candidates for the PoC. They enable time-series analysis.

Current election databases: Typically, the state or key counties have a URL where current election rolls can be downloaded. If that information is provided to Fractal, the Fractal team will ingest the data directly from such a source. Any costs are the responsibility of the PoC initiator.

Property tax records: Every county makes property tax records available for real estate comps and use by banks and construction firms. These records typically come in two flavors. One, they are available for a direct download – all of them – via a URL.

Two, they are available one at a time, where the user enters the name and address and receives one record.

The Fractal team needs **ALL** the property tax records for ALL the properties in the county. If the real estate property tax records are only available one at a time, the PoC initiator must perform a FOIA request. (If you don't know, send Fractal the county link and Fractal will determine).

Most PoCs ingest the property tax records for one or two of the most populous counties. The PoC ingests ALL the election information for the entire state.

An example FOIA is attached to this document.

3. Term of the PoC

Fractal systems are not ancient, batch report writers – they are live, real-time, always-on systems, operating at 200 million transactions per second – available from a phone or tablet.

Fractal systems can be used by those with few if any computer skills. Fractal systems can be made available to every citizen in a state if the state wishes to create apps reaching every citizen via a phone.

Fractal systems are **fully digital systems** enabling billions of records to be searched, against many databases – instantly.

The Fractal team encourages the state or organizations to use the Fractal system, including enhancing it, for several weeks. During that time, users often find new ways to resolve some of their current issues and request enhancements.

A Fractal license includes all modifications for the term of the license. Users experiencing how quickly Fractal can modify an application often become Fractal zealots.

There is no pre-determined time limit for the PoC. Fractal and the users determine if it benefits both parties to continue beyond the initial trial period.

4. Security

Fractal employs security protocols beyond what states and corporations use. Fractal protects every PoC at the same level Fractal protects its own digital assets.

5. Users

Fractal enables the state or organization to have multiple users during the PoC. Typically states and organizations have 3 -10 users during the PoC.

6. Costs

During the PoC, the initiator is responsible for ANY costs.

Those include costs for databases, if any.

They include server or hosting costs if the PoC is **not run** on the Fractal cloud. They include any travel if Fractal needs to come on site for presentations or training.

Such costs are **usually non-existent** during the PoC. Fractal trains users via Zoom calls.

Sometimes Fractal is asked to serve as expert witnesses. Fractal does not charge for expert witness testimony. Any travel expenses are expected to be reimbursed by the requesting party.

7. Publication of Results

During the PoC the Fractal team does not make any PoC results public.

When states use Fractal technology, they often find anomalies in their state rolls – election, Medicaid, contribution rolls – that may be embarrassing or involve law enforcement.

Fractal seeks to have states as customers, not adversaries.

Thus, Fractal will only communicate results to the users of the system and those users can choose what they communicate to others.

8. Ongoing Licensing

After the PoC term, a state or organization may choose to license Fractal for the PoC application.

The Fractal license is a yearly license, paid upon contract execution, and includes a single fee covering the use of Fractal. Such a license fee is communicated to the state or organization during the PoC.

Should a state or organization choose to continue using the Fractal system, the Fractal teams will load as many county property tax rolls and other databases the initiator provides.

9. PoC Deliverables

Real Time Election Roll System

The PoC will deliver a real-time application enabling voter rolls in a state to be cross-searched with other public data to find anomalies.

Undeliverable Ballot Database

The Undeliverable Ballot Database is the database of locations the county property tax records indicate are locations where a person cannot legally reside – yet the election records indicate will receive a ballot.

Audit Database

The PoC provides the ability to see EVERY change to EVERY record for full auditability.

FEC Contribution Mule Database

The FEC database for the state showing where contribution mules operate.

Statement of Work (SOW)

Both parties will have a SOW outlining the initial databases provided, the particular counties and any other deliverables the initiator requests.

Republicans are doing precisely the same thing with ballot harvesting - and hiring armies of lawyers.

In Wisconsin, even if you are dead or a completely fake voter - you remain on the voter roll. They have about 3.4 million active voters and about 3.5 million inactive voters - and their election apparatus can make any inactive guy active - one click!

How convenient is that?

Another favorite is the illegal alien - a recent phenom. Illegal aliens are being registered in droves in many blue states, plus Texas and a few kind-of-purple states.

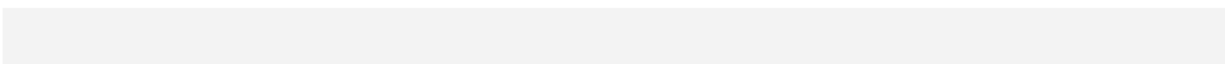

Thanks for all these counties. We are loading over 100 from 24 states. Most of them look like a kindergartner on acid built them – that is how bad county level data is. We will be ingesting all of these with the other states and we can then comment on any issues they may have.

We released Kansas and Texas this week. Georgia, Utah and Minnesota are next then Arizona and Idaho. Virginia should be after that.

As you may be aware, the Heritage Foundation maintains an Election Integrity Scorecard that compares the election laws and regulations of each state and the District of Columbia to best-practices recommendations for the administration of elections. The Scorecard is publicly available on the website of the Heritage Foundation at heritage.org/electionscorecard/.

The Foundation is making some recommended changes to the criteria used in the Scorecard and would like to confirm that the information we have for your state is correct relative to these changes. We would appreciate your either confirming or providing the correct information for the Scorecard. The accuracy of the information in the Heritage Election Integrity Scorecard is of paramount importance to us, as we know it is for you, regardless of whether you agree with our scoring methodology.

First, we would like to know whether your state is a member of the Electronic Registration Information Center, and if not, whether your state has any agreement with other states to share voter registration information that you use to compare with your own voter registration data to remove or suspend individuals who are registered in other states.

Our research indicates that Virginia currently is not a member of ERIC and has no such agreements in place with any other state. Please confirm whether this is correct and if not, please provide us with the names of the states with which you have such agreements.

Second, we would like to know whether your state conducts post-election audits, and if so, the nature and extent of those audits.

States will be graded on whether they require 1) a post-election manual check of ballots, or an effective portion of them, to verify that votes were tabulated correctly, and 2) whether a state requires a post-election audit of the state's election procedures and processes, or an effective portion of them, to verify that state and federal election laws and regulations were followed, including those requiring maintenance of an accurate voter registration list.

Our research indicates that Virginia conducts post-election tabulation audits under Virginia Code § 24.2-671.1, but does not conduct audits of election procedures and processes. Please confirm

whether this is correct and if not, please provide us with the correct information, including citations to applicable laws, regulations, or procedures.

Third, we would like to know whether there is any jurisdiction in your state that utilizes ranked choice voting or if your state has a specific prohibition against ranked choice voting.

Our research indicates that Virginia currently allows ranked choice voting and has at least one political subdivision, Arlington County, that has used ranked choice voting, under Virginia Code § 24.2-673.1. Please confirm whether this is correct.

We would appreciate your confirming the accuracy of the data we have compiled for your state as well as providing us with any missing information or corrections that you believe are warranted. We would also appreciate it if you would please provide us with this information **no later than Friday, August 18**, by emailing me at john.malcolm@heritage.org and cc'ing my colleague, Jack Fitzhenry, at jack.fitzhenry@heritage.org.
