



# VOTERS' ELECTION INTEGRITY BILL OF RIGHTS



## **I. ONLY US CITIZENS CAN REGISTER AND VOTE**

- Documentary proof of citizenship / confirmation of citizenship status to register
- Require States to compare voter rolls to state DMV data / confirm citizenship
- Require Social Security Administration to confirm citizenship status under HAVA
- Require DHS to provide data to states and confirmation of citizenship status for registration, current voter lists
- ID for voting must clearly state CITIZEN on the ID; only IDs that are issued to US Citizens and state residents can be used for registration and voting
- Eliminate registration at any agency other than election offices and DMV
- No registrations added to voter rolls unless confirmation of identity, residency and US citizenship
- Federal and state Census to confirm citizen population, apportion representation among states and representative districts (local, state, federal) based on citizenship population

## **II. VOTER ID FOR ALL VOTERS, INCLUDING VOTE BY MAIL**

- Photo ID for all methods of voting
- Permissible ID must confirm identity, residency, and US citizenship
- Additional verification for people voting by mail (QR Code, Valid passport, or other non-subjective identifier linked to unique voter registration number)

## **III. ALL BALLOTS MUST BE RECEIVED NO LATER THAN POLLS CLOSING ON ELECTION NIGHT; PROCESSED/VERIFIED BEFORE ELECTION DAY, TABULATED, REPORTED ELECTION NIGHT**

- Regardless of source or type, all ballots must be in the possession of the election office when the polls close on election day in order to be counted
- Includes ALL ballots: overseas, both military and civilian – can use fax/email
- Pre-election day processing, tabulating after polls close, reported election night

## **IV. ONLY QUALIFIED VOTERS MAY VOTE ABSENTEE; ALL OTHERS VOTE IN PERSON**

- Establish criteria for voting absentee
- Require verification of identity of all persons voting by absentee ballot
- Processing of verifications must be conducted in public
- Publish daily reports of absentees requested, sent, returned, disposition
- No ballot 'curing'

## **V. REDUCE ALLOWABLE EARLY VOTING PERIODS NOT TO EXCEED 10 DAYS**

- Require early in-person voting in designated precinct polling places, even if multiple precincts in one location; any 'vote centers' tied to precincts
- Limit days of early voting to ten (10) days prior to election

## **VI. REQUIRE IMMEDIATE AND ONGOING VOTER ROLL MAINTENANCE; CONFIRM CITIZENSHIP OF EXISTING REGISTRANTS**

- Require regular, ongoing list maintenance
- Repeal blackout periods in federal and state law
- Publish qualified voter list before early voting begins
- Election offices must accept documentation of bad registrations from citizens, mandatory action / responses

## **VI. Cont.**

- Penalties for failure to clean voter rolls, retain private right of action
- Require quarterly list maintenance, at a minimum
- List Maintenance records are public records, even if outsourced to vendor
- Prohibit sharing of DMV data with any 3rd party

## **VII. PROHIBIT / REPLACE ALL VULNERABLE / INSECURE VOTING TECHNOLOGY; REPLACE WITH REQUIRED PRE-PRINTED PAPER BALLOTS, HAND-MARKED**

- Eliminate touchscreens, ballot marking devices, QR Codes read by machines
- Only allowable for disabled voters, supervised, limited use
- Prohibit internal modems / communications capability
- Mandatory, public pre-election testing of all technology, no vendor control

## **VIII. CONFIRM ACCURACY OF ELECTIONS: REQUIRE PRECINCT, COUNTY or CITY, & STATE RECONCILIATION PRE-CERTIFICATION AND INDEPENDENT POST ELECTION AUDITS**

- Establish precinct polling, reconcile number of voters to ballots to votes
- Require post-election manual confirmations of tabulations, other processes
- Require independent audits of election procedures, results, expenditures by state auditors / 3d party (not the election offices auditing themselves)
- Eliminate risk-limiting audits

## **IX. ENSURE TRANSPARENCY OF ELECTION RECORDS: PRIVATE CAUSE OF ACTION, PENALTIES FOR DESTRUCTION OF RECORDS**

- Specify election records that must be retained and made public, include chain of custody documents
- Allow citizens to sue if records are withheld or destroyed
- Provide civil and potentially criminal penalties for violation

## **X. OVERHAUL UOCAVA: SEPARATE MILITARY AND CIVILIAN VOTERS; REQUIRE PROOF OF RESIDENCY AND CITIZENSHIP; RECEIVE BALLOTS BY POLL CLOSING ON ELECTION DAY**

- Create separate procedures for receipt / processing of overseas citizens and military / dependent voters
- Require proof of citizenship to register / vote in either process – copy of valid US passport
- Require attachment to state in order to register / vote in state
- Limit voting to presidential only if no valid in-county, or in-state registration prior to applying to vote in state from overseas, or in USA by deployed military voters

## **XI. ELIMINATE INSECURE SYSTEMS FOR MANIPULATING BALLOTS POST-ELECTION**

- Eliminate ballot curing
- Limit issuance of provisional ballots for specified purposes
- Count provisional ballots only if properly registered in county

## **XII. CITIZEN POWER TO ENFORCE ELECTION LAWS**

- Statutory standing of citizens to enforce election laws / appeal HAVA decisions
- For standing to challenge election laws, require facts showing particularized injury to individuals impacted or to be impacted, not speculative assertions with no underlying facts
