"As Sheriff of San Bernardino County, my commitment is to public safety and the rule of law. Collaboration with our federal partners plays an essential role in addressing crime and protecting our communities.

California Senate Bill 54 currently governs how state and local law enforcement agencies interact with federal immigration authorities. It limits cooperation between local law enforcement and U.S. Immigration and Customs Enforcement (ICE). As a law enforcement agency, we are committed to upholding the laws of California.

However, the landscape of immigration enforcement may change depending on decisions made at the federal level. The incoming administration could modify federal policies, and that could potentially impact how SB 54 is applied or enforced.

In the event that federal law changes, we may see litigation or judicial rulings that shape the way these policies are interpreted and enforced in California. If that happens, we will comply with any legal rulings or mandates, adjusting our practices to align with the law as directed by the courts.

This issue, like many others, can be emotionally charged, and while it may spark debate, our role as law enforcement is not to be political. We are here to uphold the rule of law and ensure that all policies are implemented fairly, justly, and in line with state and federal law." Sheriff Shannon Dicus
