As per the CBP website, the latest I-94 available is the one attached from a trip in 2019 under the B1/B2 visa. However, Mr. Filipe does have a diplomatic passport and a G-2 visa, and he traveled to the US after this date. However, when his diplomatic passport information was entered into the CBP's website, no I-94 records were returned. **Reason for Expedited Processing:** My client is currently facing an investigation promoted by the Brazilian authorities. The allegation is that his localization was uncertain in December 2022 since he was in the US as per the travel history; however, as per Brazilian records, he never left the country. In fact, he stayed in Brazil, and we have proof, such as travel records from a flight in Brazil on the same date that he was supposedly in the US. We need the FOIA to serve as additional evidence that he wasn't in the US. Clarification on this matter is imperative to close this unduly investigation.
