DMED is a comprehensive military database that contains every ICD medical billing code for any medical diagnosis in the military submitted for medical insurance billing during any given period of time. On 24 January 2022, in a roundtable convened by Senator Ron Johnson, attorney Thomas Renz reported that three military M.D. whistleblowers found a significant increase in registered diagnoses on DMED for miscarriages, cancer, and many other medical conditions in 2021 compared to a five-year average from 2016-2020 (https://www.bitchute.com/video/0yIDDQIphutY/). In a

follow-up letter from Senator Johnson to SecDef Lloyd Austin, further increases for other diseases were identified; e.g.,

Hypertension – 2,181% increase
☐ Diseases of the nervous system – 1,048% increase
☐ Malignant neoplasms of esophagus – 894% increase
☐ Multiple sclerosis – 680% increase
☐ Malignant neoplasms of digestive organs – 624% increase
□ Guillain-Barre syndrome – 551% increase
□ Breast cancer – 487% increase
□ Demyelinating – 487% increase
Malignant neoplasms of thyroid and other endocrine glands –
174% increase
☐ Female infertility – 472% increase
□ Pulmonary embolism – 468% increase
□ Migraines – 452% increase
□ Ovarian dysfunction – 437% increase
☐ Testicular cancer – 369% increase
□ Tachycardia – 302% increase

These are massive increases, and should have been easily noticed by a large number of the military doctors. This situation has been summarized quite well by Steve Kirsch in a substack article (https://stevekirsch.substack.com/p/this-medical-data-from-the-us-dod). As Kirsch states: "The DoD has claimed the increase was because events in earlier years were under reported and they have corrected the error." and "only symptoms that were elevated by the vaccine were affected; that's impossible for a computer glitch to have caused that".

If the whistleblower results are true, this is extremely problematic. First, the 2021 data covered the first ten months only. Given that the inoculations were ramped up during 2021, and there may have been a lag time between inoculations and reported adverse effects (for example, the FIFA soccer deaths increased exponentially during 2021, the widely reported insurance claims increases occurred starting Q3), the actual increases of these adverse events during 2021 may have been far greater. The numbers not shown for the final two months of 2021 may have been well out of proportion to any other two month period in 2021. One would expect increases in these diseases to have been experienced by other militaries and, in part, by civilian sectors. Some checking of these other data sources against the DMED results should prove useful.

If the DoD is lying about the glitch, it means that they are attempting to cover up a major health disaster in the military **CAUSED BY THE IRRESPONSIBLE ACTIONS OF TOP MILITARY AND CIVILIAN OFFICIALS IN THE DoD!** Further, given how closely these health effects of our military are monitored, the responsible officials in the military and other sectors must have known about these massive increases for months, but did nothing to stop them or bring them to the attention of the public. In contrast, they have doubled-down on vaccine mandates, and have discharged those who are noncompliant. One would assume, because of the sheer magnitude of the increases, they would have known since at least the end of the Summer, and probably since the end of Spring.

If they are telling the truth, that means that many people overlooked massive amounts of illness from 2016-2020. Bureaucrats, scientists, contractors, etc. somehow didn't notice these massive amounts of illness, reflecting massive incompetence. It would also reflect that we had/have one of the sickest militaries in the world, given the massive levels of these diseases, and the doctors were not aware of how sick those in their care really were.

However, if they are really stating that the previous data entries were under-reported, that is within the realm of possibility. Some military members are exposed to highly toxic environments at different points in their service, including toxic fuels, solvents, munitions, radiation for surveillance and communications, etc. One would expect they would have higher rates of illness due to these exposures. For recruiting purposes, high levels of illness due to toxic exposures would not be a selling point, and there very well could be motivations to underreport these effects. But, if that is the case, they would have been underreported in 2021 as well. Maybe they were; I have no illusions about the integrity of ANY government databases, nor the individuals responsible for maintaining these databases.

In late 2019, I came across some articles on severe problems experienced by military pilots (e.g., cancer clusters) after they retired from the military. I sent out two emails on these studies, and they are appended to this email. Not clear to me how well these illnesses were tracked while the members were in the military, or, more accurately, not clear how well these illnesses were *reported* while the members were in the military. Additionally, the synergies between the highly toxic vaccines and the other toxic exposures mentioned above could place military members at higher risk for severe illness after receiving the vaccines. Since the military demographic was at extremely low risk of experiencing severe

reactions from COVID-19, the decision to vaccinate them at all was beyond irresponsible!

If there is tracking, what is its objectivity, given the recruiting consequences that would result if it were shown that these serious diseases are in fact associated with exposures to on-board avionics (EMF in combinations with other unique stressors [chemicals, psychological stress, high and low-G forces, etc] that performance aircraft crews face).

It would be valuable to get EMF exposure data under myriad flight conditions for many different military aircraft, with all the onboard avionics in full operation. SECOND EMAIL ON PILOTS - 28 NOVENBER 2019

This morning, I received the following article about RF exposures of military pilots (https://www.mcclatchydc.com/news/nation-world/national/national-security/article237797304.html). It complements the information contained in my previous email (below).

The largest Grumman measurement reported in the article translates to <u>300 million microwatts/square meter!!!</u> This is thirty times today's FCC exposure limit, which itself is three-four orders-of-magnitude above levels shown by the cell tower studies to increase cancer incidence substantially. Lest we forget, the pilots

are also being exposed to myriad other toxic stimuli, including EMF of other frequencies, cosmic radiation, possibly fuel odors, etc., increasing the possibility of adverse effect synergies.

I have a hard time believing that these were the only RF exposure measurements done in the cabin, or that these were the highest exposures that occurred. I don't have a hard time believing these types of exposure measurements never saw the light of day in the open literature, and were actively suppressed by government-industry.

Additionally, while the gold coating may have kept a substantial amount of external RF from entering the cabin, it also would have delayed RF (that was internally generated or entered the cabin through non-gold coated non-metallic avenues) from leaving the cockpit. It mirrors a hohlraum effect.

This cockpit problem is another example of why the wireless radiation industry is <u>'Too Big to Fail'</u>. The military became network-centric decades ago. They are almost completely dependent on wireless communications and wireless detection/surveillance for all their operations. If they were to allow their labs and contractors to report the potential damage from the levels of exposures happening in the field and at their facilities, they would be forced to eliminate many decades of so-called advances in their weaponry and operations. No different in kind from their civilian counterparts, although the military may be operating at higher exposure levels because of their ultra-high performance requirements.
