

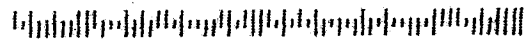

Hi my name is Caroline Morgan. I am the daughter of S. Reed Morgan, the McDonald's coffee lawyer. I need to hire an attorney.

One would think being the daughter of a well-know lawyer that I would not have a problem getting an attorney but that is not true.

The reason I cannot get an attorney is because of the federal agency that is illegally investigating me. They contact any attorney I contact before I have a chance to consult with them unbiasedly. I do not know which federal agency is illegally investigating me. They have not contacted me. I have not been ~~subpoenaed~~ issued a subpoena, nor have I been arrested nor indicted.

I have had a pin drop camera dropped from the ceiling of the apartment I was staying (with nude and pornographic images shared of me), I've had my phones scrambled or tapped, I've been followed by more than 30 cars a day (this is not as noticeable now that I have written to the ACLU & the US Dept of Justice), I've had my computer hacked (to where it was being hacked & back loaded with code even when I wasn't using it), I've had my truck illegally accessed & bugged, I've had a sensor put on me & remotely activated so anytime I went into & left a store or library the detectors beeped, I've been followed at any store I shop at, my friends, family, acquaintances, clients have been investigated so that there is something held over their head to allow the feds open access to me either through my friend's', etc pointed questions or when I would stay at their houses open access to my personal belongings & myself while I was asleep etc. (you name it, this federal agency has done it to me.)

I was finally able to have a working phone again at the end of February this year. Once I realized I was being illegally investigated by a federal agency. ~~_____~~ And I finally started receiving my mail again on 3/6/15. I am still

Again, no criminal charges have been filed on me. I do not believe I need a criminal lawyer. I have filed multiple police reports in 2014 & 2015. I have written the ACLU twice (including sending them videos of my veins being illegally accessed). I have written the US Dept of Justice twice (including sending them videos of my veins being illegally accessed). I have filed 2 grievances with the State Bar of Texas on the 2 attorneys in Austin, TX who were rude to me and were only interested in getting me to confess to something I didn't do. I have filed a grievance with the Oklahoma Bar Association on the Federal Attorney who is a long time friend of my father's for bullying me to try to give my confidential client information without letting me hire him as an attorney, and I will continue to report until this illegal investigation is stopped. I drove all the way from Austin, TX to Newport News, VA where my younger sister lives, to get help finding an attorney. I spoke to my dad briefly that night using my brother-in-law's gov't issued encrypted phone (both he & my sister are officers in the Navy) to have my dad tell me I could hire him as an attorney by sending a small check of \$10 and including a letter stating that this was retainer for me hiring him as my attorney and I could do the same for his attorney friend in Oklahoma City. And that I could have my sister mail it since my mail was/is being monitored. I asked my sister to FedEx both to my dad which she says she did. My dad texted me that he did receive it.

Neither check has been cashed. And his attorney friend said he would not let me hire him. I believe the feds have now back door investigated my parents and have something to hold over their head and that is why I can't even hire my dad as an attorney.
