My mail service is being interrupted again by a federal agency that is illegally investigating me.

I believe I am getting closer to the truth as to which agency it is and that is why they have stopped my last few certified mail/return receipt letters.

I have sent more than 10 important ~~private~~ letters via certified mail/return receipt since the beginning of this year 2015 and none have been stopped dead in their tracks like these 2 I will detail for you. (They are also copied for you and attached to the back of this letter as "C" and "D".)

Both of these correspondences detail civil rights abuses against me perpetrated by this Federal Agency. And they are continuing to abuse my civil rights now by stopping these 2 letters dead in their tracks.

I say that my mail service is being interrupted again because on 2/12/15 my little sister sent me a letter that was date stamped by her post office on 2/12/15 and I did not receive it until 3/6/15. Also I did not receive all of my March bills in February until past their due date in March. I have also included a letter that I sent to my little sister on 8/18/14 to her old address (she moved at the end of July 2014) it was labeled no forwarding address and date stamped 2/30/14. I did not receive this back, until March 2015. I have labeled this letter as "A".

I'm aware that delays happen and that accidents happen but I've sent over 10 pieces of correspondence via certified mail/return receipt this year to ensure that these very important pieces of mail get to their final destination. And on all of the other certified mail/return receipt correspondence I've sent, I have gotten detailed tracking information back including uninterrupted forward progress in a timely fashion. This includes, 2 letters written to the US Department of Justice, one letter to the FBI, one letter to the Oklahoma State Bar Association, one letter to attorney Glor'ia Allred, etc. All of these tracking receipts show multiple detailed information including uninterrupted forward progress, Attachment "B" of this letter to you is the detailed tracking information on my second letter to the US Department of Justice Civil Rights Abuse Dept. I will be more than ~~than~~ able to give you the tracking numbers of all of the certified mail/return receipt letters I've sent this year that have all made their final destination uninterrupted if you request ~~of~~ it of me. The only reason letters "C" and "D" attached have been stopped dead in their tracks is because I am getting closer to the truth.

My civil rights are once again being violated by not allowing my mail to reach its addressed parties.

§ 220.20 Procedure for Claimant

- (a) The claimant must complete and sign a Standard Form 95 (Claim for Damage, Injury or Death), and submit it with all necessary documentation to the following address:

Office of the General Counsel
 Administrative Office of the United States Courts
 One Columbus Circle, NE
 Washington, DC 20544

The claimant must:

- (1) complete both pages (or sides) of the form,
 - (2) provide sufficient information to enable the AO to investigate and evaluate the claim, and
 - (3) state a dollar amount or sum certain that he or she will accept in full satisfaction of the claim.
- (b) When a tort claim alleges negligent or wrongful conduct by a probation officer in the course of performing parole supervision duties, the claim must be submitted to the United States Parole Commission rather than the AO.

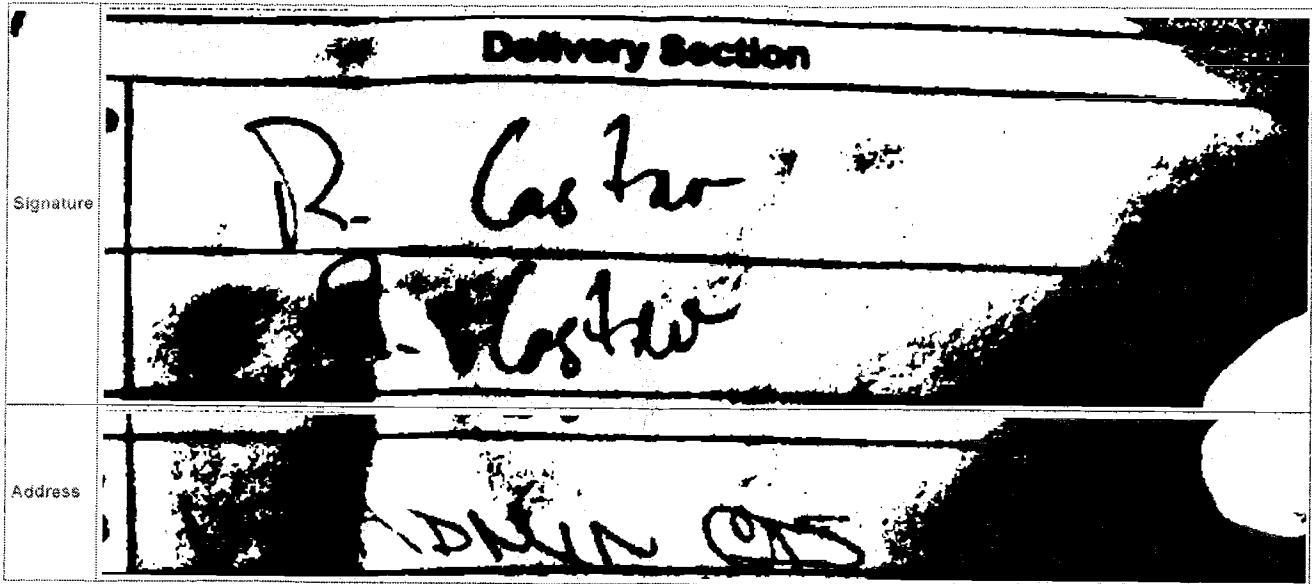


