Just want to update you on the status of your request. At this point, after removing extraneous email chatter and most duplicative records, I'm still working with over 10,000 pages of records. As a result, I don't believe I'll be done with my review by the end of this month. I hope to be able to devote the next couple days to your case and will check in with you again on Monday to let you know how I'm progressing.

There are a lot of draft documents which will most likely be withheld under FOIA Exemption (b)(5) (deliberative and pre-decisional material). If you'd be willing to exclude drafts, review time could significantly lessen. Please let me know at your earliest convenience if you'd be willing to further narrow the scope of your request. Also, feel free to call me if you would like to discuss.
