On 02-26-2015 I spoke to Ci # 2015-10 who told me that Alex would front him a pound of Ice. I told the CI to set it up for tomorrow.

On 02-27-2015 I received a call from the CI who told me that Alex to call the CI at noon.

On 03-12-2015 at 0724 hrs the Tulsa County Drug Task force went to 8604 S Atlanta pl to serve a search warrant. The team approached the front door and Major Huckeby knocked on the front door and announced Sheriff's Office we have a search warrant come to the door.

Major Huckeby repeated the announcement with no response and then he had Deputy Huckeby breach the door. Major Huckeby then saw a Hispanic male later identified as Alajandro Eutimo. Major Huckeby told Alajandro to come out and he would not respond to orders.

Major Huckeby was able to get Alajandro to come out and he was secured on the porch after a struggle.

We cleared the house and we did not find anyone else in the house.

Search warrant service: I served a copy of the search warrant to Alajandro Eutimo.

Miranda warning: I advised Alajandro Eutimo his rights and he said that he understood his rights but he wanted to talk to his lawyer.

As a result of the search warrant Alandro Eutimo was found to be in possession of two baggies of cocaine, one baggy of Ice ,phone visa with Alajandro Eutimo name on it that was with the cocaine.

We also recovered to motor cycles that were reported stolen traxis numbers 067467C and 067462 B.

I did not see any drug tax stamp on or around the cocaine or the Ice. Deputy Boyd conducted a ODV904 field test, showed positive for cocaine. Deputy Boyd also conducted a ODV923 field test on the ice. Showed positive for methamphetamine.
