4. Any return of service, certified mail receipt, certified mail number and/or any documents that show the date that the Prosperity Bank subpoena(s) where served.


Pursuant to 5 USCS § 552(a)(6)(A)(i), I request that you make a determination regarding the release of this information within the 20 day statutory period.
