Dear Governor Cuomo:

Inequity in education is probably the civil rights issue of our time. There are two education systems in this state. Not public private. One for the rich and one for the poor and they are both public systems.

These words are as true today as when you spoke them while running for Governor in 2010. In fact inequity has actually grown since then. According to The Education Trust, one of the nation's leading authorities on educational inequity, New York State ranks number two nationally in educational inequality due to inequality of funding. This is a sad statistic, but it is a sadder reality for poor children and far too often for black and Latino students like the ones who attend the schools where we have the privilege to serve as school leaders.

There is a solution. The Campaign for Fiscal Equity lawsuit has never been fully funded. According to the State Education Department the state owes schools \$4.4 billion in Foundation Aid as a result of CFE. New York City schools are owed \$1.9 billion. When you were running for Governor you acknowledged this funding was owed to our schools saying, *"The state is supposed to equalize or come close to equalizing with its funding. That's the CFE lawsuit that the state is yet to fully fund."*

Yet you have yet to address these inequalities. Your first five budget proposals included no foundation aid and your proposal this year includes only \$266 million statewide with no plan to ever fully fund CFE. Meanwhile the State Assembly has proposed \$1.1 billion in Foundation Aid this year and a four-year phase in of the full \$4.4 billion that is owed statewide. If the Assembly plan is enacted, finally the CFE money will be fully delivered. With your support and leadership this can happen and your vision of equitable opportunity for all of our students can become reality.

For the students whose education we hold the stewardship over, this funding would be the difference maker. It would mean smaller class sizes, more art and music, more diverse and challenging curriculum, extended learning time and much more. We know you share our belief that these educational resources are vital to our children's future. In wealthy suburban communities these are standard fare. There is no reason our children should be denied these opportunities due to the racial and economic inequalities that indeed make education a critical civil rights issue of our time.

While we are asking for your leadership to ensure a four-year phase-in of CFE funding, we also wish to thank you for making community schools a priority. Community schools offer a hopeful and truly innovative solution to support the social, emotional, health and academic needs of our students and their families. We would ask that you ensure that there is at least \$200 million for community schools in the final budget this year.

We appreciate your leadership for our state and our children, please ensure that this year's budget includes a plan to end the two systems of education you so boldly identified by fulfilling New York State's constitutional obligation to fully fund CFE. Strong words are important to gaining justice, but actions speak louder than words.
