

## **Oklahoma employers opting out of the state's workers comp plan**

Below is the list of Oklahoma employers who have chosen to opt out of the state's workers compensation plan, according to the Oklahoma Insurance Department.

The opt-out provision of state law has been found unconstitutional by the state Workers Compensation Commission and an appeal is pending in the Supreme Court. Because of the challenge, the commission issued a stay and is expected to take no action on claims filed by employees of these companies until the Supreme Court rules.
